RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, GATSBY SPAS INC., a Florida corporation (“**Gatsby**”), JACUZZI INC., a Delaware corporation (“**Jacuzzi**”), and SUNDANCE SPAS, INC., a California corporation (“**Sundance**” and, together with Gatsby and Jacuzzi, individually and collectively, the “**2007 Pledgor**”), granted a continuing security interest in and lien on trademarks, service marks, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles, all registrations thereof, applications therefor and related rights, and all goodwill of the business symbolized thereby (collectively, the “**2007 Trademarks**”) to BANK OF AMERICA, N.A., as secured party (“**Secured Party**”), as set forth in the ABL Trademark Security Agreement, dated as of February 7, 2007, between the 2007 Pledgor and Secured Party (the “**2007 Trademark Security Agreement**”), and recorded with the United States Patent and Trademark Office (“**USPTO**”) on March 26, 2007 at Reel 3507, Frame 0351;

WHEREAS, NEW DIMENSION ONE SPAS, INC., a California corporation (“**New Dimension**”), and THERMOSPAS HOT TUB PRODUCTS, INC., a Delaware corporation (“**ThermoSpas**” and, together with New Dimension, individually and collectively, the “**2013 Pledgor**”), granted a continuing security interest in and lien on trademarks, service marks, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles, all registrations thereof, applications therefor and related rights, and all goodwill of the business symbolized thereby, (collectively, the “**2013 Trademarks**”) to Secured Party, as set forth in the ABL Trademark Security Agreement, dated as of June 12, 2013, between the 2013 Pledgor and Secured Party (the “**2013 Trademark Security Agreement**”), and recorded with the USPTO on June 13, 2013 at Reel 5064, Frame 0156;

WHEREAS, RHT, INC., an Illinois corporation (the “**2017 Pledgor**” and, together with the 2007 Pledgor and the 2013 Pledgor, individually and collectively, “**Pledgor**”), granted a continuing security interest in and lien on trademarks, service marks, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles, all registrations thereof, applications therefor and related rights, and all goodwill of the business symbolized thereby (collectively, the “**2017 Trademarks**” and, together with the 2007 Trademarks and the 2013 Trademarks, collectively, the “**Trademarks**”) to Secured Party, as set forth in the ABL Trademark Security Agreement, dated as of June 28, 2017, between 2017 Pledgor and Secured Party (the “**2017 Trademark Security Agreement**” and, together with the 2007 Trademark Security Agreement and the 2013 Trademark Security Agreement, collectively, the “**Trademark Security Agreements**”), and recorded with the USPTO on July 5, 2017 at Reel 6099, Frame 0911;

WHEREAS, Pledgor has requested that Secured Party terminate, release and reassign its security interest in and liens on all right, title and interest of Pledgor in, to and under all of the Trademarks, including those identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby (collectively, the “**Trademark Collateral**”); and

WHEREAS, Pledgor has requested Secured Party provide a document suitable for recording in the USPTO to evidence the release of Secured Party’s security interest in and liens on the Trademark Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. Fully and irrevocably releases, terminates and discharges, and reassigns to Pledgor, any and all liens, security interest, right, title and interest of Secured Party pursuant to the Trademark Security Agreements in, to and under the Trademark Collateral, without recourse or representation or warranty, express or implied, of any kind, including:

(a) all renewals and extensions of the foregoing;

(b) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(c) all income royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof;

2. Agrees that any power of attorney or similar rights granted by Pledgor to Secured Party pursuant to or in connection with the Trademark Security Agreements is terminated; and

3. Authorizes and requests that this Release of Security Interest in Trademarks be recorded at the USPTO.

This Release of Security Interest shall be governed by, and construed in accordance with, the law of the State of New York applicable to contracts made and to be performed in the State of New York.
