**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of March 13, 2019 (the “Effective Date”), is made by **JEFFERIES FINANCE LLC**, a Delaware limited liability company, in its capacity as collateral agent (the “Collateral Agent”), in favor of **FM NETWORKS LLC**, a New York limited liability company with an address at Eleven Penn Plaza, New York, New York, 10001, and **FUSE, LLC**, a Delaware limited liability company with an address at 700 North Central Ave., Suite 600, Glendale, California 91203 (collectively, the “Pledgors”).

WHEREAS, the below Pledgors entered into certain trademark security agreements (collectively, the “Trademark Security Agreements”) with Collateral Agent as follows:

Trademark security agreement dated July 1, 2014 between SITV, LLC (nka Fuse, LLC) and FUSE NETWORKS LLC (trademarks formerly owned by Fuse Networks LLC are now owned by FM Networks LLC) and Collateral Agent, notice of which was recorded on July 3, 2014 at Reel 5316, Frame 0081;

Trademark security agreement dated August 26, 2016 between FM NETWORKS LLC and FUSE, LLC and Collateral Agent, notice of which was recorded on August 26, 2016 at the United States Patent and Trademark Office at Reel 5865, Frame 0159;

Trademark security agreement dated November 17, 2016 between FUSE, LLC and Collateral Agent, notice of which was recorded on November 18, 2016 at the United States Patent and Trademark Office at Reel 5924, Frame 0566;

Trademark security agreement dated April 26, 2018 between FUSE, LLC and Collateral Agent, notice of which was recorded on April 26, 2018 at the United States Patent and Trademark Office at Reel 6320, Frame 0890.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreements.

WHEREAS, Pledgors granted the Collateral Agent, under the terms of the Trademark Security Agreements, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of their Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Collateral, including the Trademark Collateral, as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its right, title and interest in, to and under the Collateral, including the Trademark Collateral, of the Pledgors, and assigns, transfers and conveys to Pledgors any interest in such intellectual property, including the Security Interest.
