## ASSIGNMENT OF TRADEMARKS



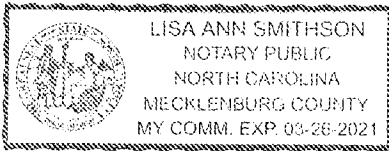
