RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE dated as of March 15, 2019 (this “Release”) is made by WEBSTER BANK, NATIONAL ASSOCIATION, acting in its capacity as lender (the “Lender”) under that certain Trademark Security Agreement, dated as of January 10, 2014, as amended by that certain Amendment No. 1 to Trademark Security Agreement, dated as of October 31, 2014, as amended and restated in its entirety by that certain Amended and Restated Intellectual Property Security Agreement, dated as of December 23, 2015, as amended and restated in its entirety by that certain Second Amended and Restated Intellectual Property Security Agreement, dated as of July 11, 2017, and as amended and restated by that certain Third Amended and Restated Intellectual Property Security Agreement, dated November 28, 2018 (as further amended, supplemented or modified and in effect from time to time, collectively, the “IP Security Agreement”) between SOUND SEAL, INC., a Delaware corporation (the “Grantor”) and the Lender.

WHEREAS, pursuant to (i) the IP Security Agreement which was recorded with the United States Patent and Trademark Office on January 13, 2014 at Reel/Frame 5191/0582, on November 14, 2104 at Reel/Frame 5401/0262, on January 27, 2016 at Reel/Frame 037593/0155, on January 27, 2016 at Reel/Frame 5716/0379, on January 29, 2016 at Reel/Frame 5719/0144, on July 19, 2017 at Reel/Frame 6108/0500, and on December 3, 2018 at Reel/Frame 6492/0920 and (ii) recorded with the United States Copyright Office on February 1, 2016 at V9927 D495 P1-16, the Grantor granted to the Lender a continuing security interest in all of Grantor's right, title and interest in, to and under the Collateral (as defined in the IP Security Agreement and for purposes of this release, the “Released Collateral”), including but not limited to those trademark registrations and applications set forth on the attached Schedule A, those patents and patent applications set forth on the attached Schedule B, those copyrights as set forth on the attached Schedule C;

WHEREAS, the Grantor has requested and the Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office and the United States Copyright Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate all of the liens and security interest created under the IP Security Agreement in the Released Collateral, (b) release all of its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.


