TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “Assignment”), is made and entered into as of February 20, 2019, by and between J. & P. Coats, Ltd., a private limited company incorporated under the laws of Scotland, United Kingdom (“Assignor”), and Coats & Clark Inc., a Delaware corporation (“Assignee”), (each, an “Assigning Party” and collectively, the “Assigning Parties”). This Assignment is effective as of the Closing Date, and is a required deliverable at the Closing, of that certain Purchase Agreement (terms as defined below) (“Effective Date”).

BACKGROUND

WHEREAS, (a) pursuant to that certain Stock Purchase Agreement, dated as of January 21, 2019 (the “Purchase Agreement”), by and among (i) Coats North America Consolidated, Inc., a Delaware corporation (“Seller”), (ii) Assignee, (iii) Spinrite Intermediate Holdings, Inc. a Delaware corporation (“Buyer”), and (iv) certain other parties thereto (together with Seller, Assignee, and Buyer, the “Parties”), Buyer has purchased from Seller all of the issued and outstanding capital stock of Assignee on the terms and subject to the conditions set forth therein, and (b) pursuant to the Canadian Purchase Agreement (as defined in the Purchase Agreement), an affiliate of Buyer purchased from an affiliate of Seller the assets described therein on the terms and subject to the conditions set forth therein and in the Purchase Agreement;

WHEREAS, in connection with the transactions contemplated by the Purchase Agreement, Assignor owns and has agreed to assign to Assignee all right, title, and interest to the Assigned Trademarks herein; and

WHEREAS, capitalized terms used but not defined herein shall have the respective meanings ascribed to such terms in the Purchase Agreement.

NOW THEREFORE, in consideration of the foregoing, in reliance upon the respective covenants, agreements, representations and warranties of the Assigning Parties set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assigning Parties, intending to be bound legally, hereby agree as follows

1. Assigned Trademarks. For the purposes of this Assignment, “Assigned Trademarks” means the trademarks specified on Schedule A hereto.

2. Assignment. As of the Effective Date, Assignor hereby irrevocably conveys, transfers and assigns to Assignee, its successors and assigns, and Assignee hereby accepts from Assignor, in the jurisdictions specified in Schedule A (collectively, the “Assigned Jurisdictions”), all right, title, and interest in and to the Assigned Trademarks, respectively, together with all rights of action accrued, accruing and to accrue under and by virtue hereof, including all right to sue or otherwise recover for past infringement and to receive all damages, payments, costs and fees associated therewith. The assignment of the Assigned Trademarks herein includes assignment of all goodwill associated therewith. The assignment of the Assigned Trademarks is being made for the consideration set forth in the Purchase Agreement. For the avoidance of doubt, the Assigning

Parties acknowledge that Assignee's right to use, register and seek to register the CLARK, CLARK'S, COATS & CLARK and COATS & CLARK'S trademarks shall be limited to the US and Canada, that Assignee shall have no right to use, register, or seek to register the CLARK, CLARK'S, COATS & CLARK and COATS & CLARK'S trademarks in any jurisdiction other than the US and Canada, and that Assignor does not have the right to use, register, and seek to register the CLARK, CLARK'S, COATS & CLARK and COATS & CLARK'S in any jurisdiction.

3. Integration with Purchase Agreement. This Assignment is made pursuant to the Purchase Agreement. Without limiting the generality of its other obligations, Assignee acknowledges and agrees that it is taking assignment of the Assigned Trademarks subject to that certain Temporary License Agreement, dated July 2015, between J&P Coats and Aurelius Theta Invest Holding GMBH (the "Temporary License") and, accordingly, Assignee agrees to comply with all obligations under the Temporary License that are applicable to the Assigned Trademarks subject to the relevant obligations of Licensor as defined under the Temporary License. As set forth in the Purchase Agreement, Assignor shall pay Assignee any and all royalties received by Assignor under the Temporary License that are attributable to Company's Aurelius-Licensed Marks.

4. Further Assurance. Upon the request of Assignee, provided such request is made within ten (10) years of the Closing Date, Assignor shall, at the expense of Assignee, execute and deliver any and all instruments and documents and take such other future actions as may be necessary or reasonably requested by Assignee, its successors or assigns, to document the aforesaid assignment and transfer and to enable Assignee, its successors and assigns, to secure, register, maintain, enforce and otherwise fully protect its rights in and to the Assigned Trademarks, as applicable, as intended in this Assignment and as further set forth in Section 6(a) of the Purchase Agreement.

5. Protection of Base Marks. Assignee acknowledges that the Assigned Trademarks specified as the "Base Marks" in Schedule B served as the basis for certain international registrations. To preserve the validity of such international registrations, Assignee shall, for a period of five (5) years from the issuance of the applicable registration (the "Dependency Period"), take all commercially reasonable action necessary or appropriate to maintain and renew the Base Marks registrations, provided that Assignee is under no obligation to continue to use any of the Base Marks and may discontinue use of any Base Marks at any time. Assignee shall not be liable for any resulting impact of any such discontinued use on any other registrations related to such Base Mark, provided that, if Assignee intends to discontinue use of any Base Mark within the Dependency Period of such mark, Assignee shall: (a) provide Assignor with written notice of such intent at least three (3) months prior to discontinuing use of the Base Mark; and (b) if requested by Assignor, assign such Base Mark back to Assignor before Assignee discontinues such use. Assignor and Assignee shall each promptly notify the other upon becoming aware of any claim, challenge, or other action raised or that occurs during the Dependency Period of a Base Mark that could directly affect the validity of such Base Mark ("Claim"). Neither Assignee, nor Assignor is under any obligation to defend against a Claim. If Assignee decides to defend against a Claim, Assignor shall (for so long as the applicable Base Mark is in its Dependency Period) equally share all expenses related to such defense with counsel reasonably acceptable to both Assigning Parties.

For all other Claims, Assignor may, but is not obligated to defend against such Claims. If Assignor defends against such a Claim, (x) if Assignee is using the Base Mark subject to the Claim, and Assignor uses counsel reasonably acceptable to both Assigning Parties, Assignee shall equally share all expenses related to such defense provided, otherwise (y) Assignor shall bear the full cost of defending such Claim, and Assignee shall, at Assignor's expense, reasonably assist Assignor in the defense of such Claim. Neither Assigning Party shall agree to any settlement of a Claim that affects or involves such Base Mark without the other's consent.

6. Binding Effect; Assignment. This Assignment shall be binding upon and shall inure to the benefit of the Assigning Parties and their successors and assigns. Neither Assigning Party may assign or delegate all or any portion of its rights, obligations or liabilities under this Agreement without the prior written consent of the other Assigning Party, which consent shall not be unreasonably withheld, conditioned or delayed; provided, however, that each Assigning Party may, without such consent, transfer or assign this Agreement (by operation of law or otherwise) (a) to any Affiliate or to any other Persons, by way of merger, sale of stock, or other transfer of substantially all of its assets, or (b) for collateral security purposes to any lender providing financing to such Assigning Party. Notwithstanding the foregoing, in the event that Assignee transfers any or all of its interests in and to the Assigned Marks, Assignee shall require that the transferee be bound by the terms of this Agreement. Any purported assignment in violation of this Section 6 shall be void.

7. Entire Agreement. This Assignment, together with the Purchase Agreement and Ancillary Agreements, including all schedules and exhibits hereto and thereto, contain all of the terms, conditions and representations and warranties agreed upon or made by the Parties and Assigning Parties relating to the subject matter of this Assignment and supersede all prior and contemporaneous agreements, negotiations, correspondence, undertakings and communications of the Parties and Assigning Parties or their representatives, oral or written, respecting such subject matter. In the event of a conflict between this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall govern.

8. Governing Law; Jurisdiction and Venue. This Assignment and any claim or controversy hereunder shall be governed by and construed in accordance with the Laws of the State of New York without giving effect to the principles of conflict of laws thereof. Any legal action, suit or proceeding arising out of or relating to this Assignment may only be instituted in any state or federal court in the State of New York, and each party hereto waives any objection which it may now or hereafter have to the laying of the venue of any such action, suit or proceeding, and irrevocably submits to the jurisdiction of any such court in any such action, suit or proceeding.

9. Indemnification. The Assigning Parties acknowledge that the representations, warranties and indemnities in the Purchase Agreement that relate to Intellectual Property that is used in the operation of the Business as currently conducted apply to the Assigned Trademarks, subject to all terms, conditions and limitations in the Purchase Agreement applicable to such representations, warranties and indemnities.

10. Notices. Any notice or other communication required or permitted under this Assignment shall be deemed to have been duly given and made as permitted under the Purchase Agreement.

11. Waiver. Waiver of any term or condition of this Assignment by any Assigning Party shall only be effective if in writing and shall not be construed as a waiver of any subsequent breach or failure of the same term or condition, or a waiver of any other term or condition of this Assignment.

12. Headings. The headings contained in this Assignment are intended solely for convenience and shall not affect the rights of the Assigning Parties.

13. Severability. If any term, provision, agreement, covenant or restriction of this Assignment is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the terms, provisions, agreements, covenants and restrictions of this Assignment shall remain in full force and effect and shall in no way be affected, impaired or invalidated so long as the economic or legal substance of the Assignment is not affected in any manner materially adverse to any Assigning Party hereto. Upon such a determination, the Assigning Parties shall negotiate in good faith to modify this Assignment so as to effect the original intent of the Assigning Parties as closely as possible in a reasonably acceptable manner so that the Assignment may be consummated as originally contemplated to the fullest extent possible.

14. Counterparts; Facsimile Signatures. This Assignment may be executed in any number of counterparts, each of which shall be an original as regards any party whose signature appears thereon and all of which together shall constitute one and the same instrument. Facsimile signatures or signatures received as a pdf attachment to electronic mail shall be treated as original signatures for all purposes of this Assignment. This Assignment shall become binding when one or more counterparts hereof, individually or taken together, shall bear the signatures of all Assigning Parties reflected hereon as signatories.

15. Usage. Unless the express context otherwise requires: (a) the words “hereof,” “herein,” and “hereunder” and words of similar import, when used in this Assignment, shall refer to this Assignment as a whole and not to any particular provision of this Assignment; (b) terms defined in the singular shall have a comparable meaning when used in the plural, and vice versa; (c) references herein to a specific Section or Schedule shall refer, respectively, to Sections or Schedules of this Assignment; (d) wherever the word “include,” “includes,” or “including” is used in this Assignment, it shall be deemed to be followed by the words “without limitation”; (e) the word “or” shall not be exclusive; (f) references to “written” or “in writing” include in electronic form; (g) any reference to “days” shall mean calendar days unless Business Days are expressly specified; (h) references herein to any contract or agreement (including this Assignment) mean such contract or agreement as amended, restated, supplemented or modified from time to time in accordance with the terms thereof; (i) with respect to the determination of any period of time, the word “from” means “from and including” and the words “to” and “until” each means “to but excluding”; (j) references herein to any Law means such Law as amended, modified, codified, reenacted, supplemented or superseded in whole or in part, and in effect from time to time; and (k)


references herein to any Law shall be deemed also to refer to all rules and regulations promulgated thereunder.
