- 1. terminates the Intellectual Property Security Agreement and releases, terminates and discharges all liens and security interests in all of Grantor's right, title and interest in, to and under (a) the Trademarks, including those identified in <u>Schedule A</u> hereto, (b) the Copyrights, including those identified in <u>Schedule B</u> hereto, and (c) the Patents, including those identified in <u>Schedule C</u> hereto, and assigns, transfers and conveys to Grantor any interest in such Trademarks, Copyrights and Patents;
- 2. authorizes and requests that the applicable governmental authority note and record the existence of the release hereby given; and
- 3. agrees that it shall, at the Grantor's sole cost and expense and at any of the Grantor's, or its successor's or assign's, reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.
