INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "IP Security Agreement"), dated as of April 10, 2019, by TeleTracking Technologies, Inc., a Delaware corporation with a principle business address of The Times Building, 336 Fourth Avenue, Pittsburgh, Pennsylvania 15222 ("Grantor"), in favor of Brian E. Schuliger, an individual residing at 425 Tyburn Drive, Wexford, Pennsylvania 15090 ("Schuliger"), Stephen P. Nash, an individual residing at 440 Gregory Lane, Boulder, Colorado 80302 ("Nash"), Frank J. Gori, an individual residing at 1905 Foxview Circle NW, Washington, DC 20007 ("Gori") and Loretta M. Shahade, an individual residing at 653 Woodcrest Drive, Pittsburgh, Pennsylvania 15205 ("Shahade" and together with Schuliger, Nash and Gori, the "Lenders" and each a "Lender");

WHEREAS, Grantor and each Lender have entered into a Secured Promissory Note (each Secured Promissory Note together with all exhibits, schedules, extensions, renewals, amendments, substitutions and replacements thereto and thereof is collectively referred to as the "Notes") dated as of the date hereof;

WHEREAS, Grantor has entered into a Redemption Agreement and a Settlement Agreement (the Redemption and Settlement Agreements together with all exhibits, schedules, extensions, renewals, amendments, substitutions and replacements thereto and thereof is referred to as the "Agreements"), dated as of the date hereof pursuant to which certain obligations owed to Lender are secured;

WHEREAS, pursuant to the terms of the Notes and Agreements, Grantor has granted to Lenders a security interest in substantially all the assets of Grantor, including certain intellectual property of the Grantors, and has agreed to execute and deliver this IP Security Agreement, for recording with national, federal and state government authorities, including, but not limited to, the United States Patent and Trademark Office and the United States Copyright Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby grant to Lenders a security interest in all of Grantor's right, title and interest in, to and under the following wherever located, and whether now existing or hereafter arising or acquired from time to time (the "IP Collateral"):

- (a) the patents and patent applications set forth in Schedule 1 hereto and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (the "Patents");
- (b) the trademark registrations and applications set forth in Schedule 1 hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof (the "Trademarks"), excluding only United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant, attachment or enforcement of a security interest therein would, under applicable federal law, impair the registrability of such applications or the validity or enforceability of registrations issuing from such applications;
- (c) the copyright registrations, applications set forth in Schedule 1 hereto, and all extensions and renewals thereof (the "Copyrights");

- (d) the websites and internet domain name registrations set forth in Schedule 1 hereto, and all renewals thereof;
- (e) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
- (f) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- (g) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Nothing herein shall be construed as an assignment of any Patent, Trademark or Copyright application of Grantor to Lenders. Grantor authorizes the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other government officials to record and register this IP Security Agreement upon request by the Lenders. This security interest is granted in conjunction with the security interests granted to Lenders pursuant to the Agreements. Grantor hereby acknowledges and affirms that the rights and remedies of Lenders with respect to the security interest in the IP Collateral made and granted hereby are more fully set forth in the Notes and the Agreements, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. This IP Security Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns. This IP Security Agreement and any amendment hereto may be executed in several counterparts and by each party on a separate counterpart, each of which, when so executed and delivered, shall be an original, but all of which together shall constitute but one and the same instrument. Capitalized terms used in this IP Security Agreement as defined terms which are not defined herein but which are defined in the Notes or the Agreements shall have the meanings which are given to them in the Notes or the Agreements.
