#### ASSIGNMENT

- 2. <u>Further Assurances</u>. Assignor shall, at no cost to Assignee, but at Assignee's expense, take all actions and execute all documents necessary or desirable to record and perfect the interest of Assignee in and to the Marks, and shall not enter into any agreement in conflict with this Assignment.
- 3. <u>Governing Law</u>. This Assignment shall be governed by and construed in accordance with the laws of the State of Oklahoma (regardless of the laws that might otherwise govern under applicable Oklahoma conflict of law principles).
