RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (Second Lien)

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made as of February 22, 2019, by THE BANK OF NEW YORK MELLON as second lien agent (in such capacity, the "Second Lien Agent"), in favor of DJO, LLC, DJO Consumer, LLC, Encore Medical, L.P., Elastic Therapy, LLC, Rikco International, LLC, Encore Medical Asset Corporation, and Empi, Inc. (collectively, the "Grantors").

Reference is made hereby to (i) the Indenture, dated as of May 7, 2015 (as supplemented by the First Supplemental Indenture, dated as of May 7, 2015, the "Second Lien Indenture"), among DJO Finance LLC, as issuer (the "Company"), DJO Finance Corporation, as co-issuer (the "Co-Issuer" and, together with the Company, the "Issuers"), the Grantors party thereto and The Bank of New York Mellon, as Trustee (in such capacity, the "Second Lien Trustee") and Second Lien Agent, and (ii) the Second Lien Security Agreement, dated as of May 7, 2015 (the "Second Lien Security Agreement"), among the Issuers, the Grantors from time to time party thereto, and the Second Lien Agent.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Second Lien Agent, on behalf of itself and the Second Lien Secured Parties (as defined in the Indenture), does hereby agree as follows:

1. The Second Lien Agent, without recourse, representation or warranty of any kind, hereby (a) terminates any security agreement to which it is a party as listed in Schedule A attached hereto, (b) releases, relinquishes, terminates and discharges the liens on property identified on Schedule A (including, without limitation, any liens on property in connection with any security documents listed on Schedule A attached hereto and (c) reassigns to the Grantors any and all right, title and interest of any nature whatsoever which it may hold in or to any of the copyrights, trademarks or patents (including, without limitation, the copyrights, trademarks and patents identified on Schedule A attached hereto), associated common law rights and goodwill appurtenant thereto, and reassigns to the Grantors any and all rights to sue for and collect damages for past infringements, in each case to the extent granted under the security agreements listed in Schedule A attached hereto.
2. The Second Lien Agent authorizes the Register of Copyrights, the Commissioner of Trademarks, the Commissioner of Patents, each as applicable, and any other applicable governmental authority to record this Release.
3. At the reasonable request and sole expense of the Grantors, the Second Lien Agent, on behalf of itself and the Second Lien Secured Parties, agrees to execute, acknowledge and deliver all such further instruments delivered to it and requested of it by the Grantors necessary to carry out the purposes of this Release.
