**TERMINATION AND RELEASE OF A SECURITY
INTEREST
TRADEMARKS**

May 10, 2019

THIS TERMINATION AND RELEASE OF LIEN (this “Release”) is made as of May 10, 2019, by Ares Capital Corporation, in its capacity as administrative agent under the Credit Agreement (as defined below) (the “Administrative Agent”), in favor of DISC Intellectual Properties, LLC and GEP Software Technologies, LLC (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, the Borrower, GEP Administrative Services, Inc., a Delaware corporation, as Holdings, the Lenders from time to time party thereto, and Ares Capital Corporation, as Administrative Agent, are party to that certain Credit Agreement, dated as of May 8, 2017 (as amended by that certain Amendment No. 1 to Credit Agreement, dated as of November 14, 2017, that certain Amendment No. 2 to Credit Agreement, dated as of April 30, 2018, and that certain Amendment No. 3 to Credit Agreement dated as of December 19, 2018 and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, the Grantors executed and delivered that certain Guaranty and Security Agreement dated as of May 8, 2017 (as amended, restated, extended, supplemented, waived, or otherwise modified in writing from time to time, the “Guaranty and Security Agreement”), pursuant to which the Grantors executed and delivered that certain Trademark Security Agreement dated as of May 8, 2017, which was recorded with the United States Patent and Trademark Office on May 12, 2017 at Reel 006057, Frame 0943 (the “Trademark Security Agreement” and together with the Guaranty and Security Agreement, the “Security Agreements”);

WHEREAS, pursuant to the Security Agreements, each Grantor, as collateral security for the prompt and complete payment and performance when due of the Secured Obligations of such Grantor, mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the “Trademark Collateral”):

- (a) all of its Trademarks, including, without limitation, those referred to on Schedule I hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under or with respect to any of the foregoing or otherwise with respect to such Trademarks, including, without limitation, all rights to sue and recover at law or in equity for any past, present or future infringement, misappropriation, dilution, violation or other impairment thereof; and

WHEREAS, pursuant to that certain Payoff Letter dated as of May 10, 2019, entered into by the Administrative Agent, Holdings and the Borrower, the Administrative Agent acknowledged the full payment and performance of the Secured Obligations of the Grantors, and accordingly the Grantors have requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and in exchange for good and valuable consideration, Administrative Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

2. Release of Security Interest; Further Assurances. Administrative Agent hereby (i) fully terminates, releases, relinquishes and discharges all of its Lien on and security interest in the Trademark Collateral, including the trademark registrations listed in Schedule I hereto (ii) re-transfers and re-assigns to the applicable Grantor any and all right, title and interest that it may have in, to and under the Trademark Collateral, (iii) agrees that it shall execute and deliver all other documents and do all other acts necessary or desirable to relinquish its security interests in the Trademark Collateral, effect the release of such rights to each Grantor and confirm each Grantor's right, title and interest in the Trademark Collateral, (iv) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Administrative Agent's rights under each of the Credit Agreement and the Security Agreements with respect to the Trademark Collateral.



Further, this Release may be executed in any number of counterparts, each of which when executed and delivered is an original and all of which together evidence the same agreement.

4. Governing Law. This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.




