Release of Security Interest in Intellectual Property

**Liguria Foods, Inc.**

WHEREAS, Liguria Foods, Inc., a Delaware corporation ("Grantor"), granted a security interest in and lien upon certain intellectual property and related rights to Goldman Sachs Lending Partners LLC ("Goldman"), as set forth in the Intellectual Property Security Agreement, dated as of April 6, 2016, between Grantor and Goldman (as amended, supplemented, restated or otherwise modified from time to time, the "IP Security Agreement");

WHEREAS, Goldman assigned to Wells Fargo Bank, National Association ("Secured Party") all of its rights and obligations under and interest in the IP Security Agreement, and Secured Party assumed such rights, obligations, and interest, as set forth in the Intellectual Property Security Agreement Assignment and Assumption, dated as of November 20, 2018, by and between Goldman, Secured Party, and Grantor ("IP Assignment and Assumption");

WHEREAS, an executed copy of the IP Security Agreement was recorded in the United States Patent and Trademark Office on April 7, 2016 at Reel 5767, Frame 0129;

WHEREAS, an executed copy of the IP Assignment and Assumption was recorded in the United States Patent and Trademark Office on November 29, 2018 at Reel 6541, Frame 0723;

WHEREAS, Grantor has requested that Secured Party release and reassign its interest in the intellectual property more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:


1. releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the IP Security Agreement and IP Assignment and Assumption in the intellectual property more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind; and
2. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.
