TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made as of October 22, 2018, by and between TRION WORLDS (ABC), LLC, a California limited liability company (“**Seller**”), as Assignee for the Benefit of Creditors of Trion Worlds, Inc., a Delaware corporation, and PADMAPANI GMBH, a company organized under the laws of Germany (“**Buyer**”). **Seller and Buyer** and Golden Gate Games Inc. are parties to a certain Asset Purchase Agreement dated as of October 22, 2018, (the “**Asset Purchase Agreement**”). Capitalized terms used without definitions herein shall have the meanings ascribed to such terms in the Asset Purchase Agreement.

WHEREAS, Seller has agreed to sell to Buyer, and Buyer has agreed to acquire from Seller, all of **Seller’s** rights, title and interest in and to the trademarks and/or service marks identified in Schedule A attached hereto (the “**Marks**”); and

WHEREAS, the parties accordingly wish to execute this recordable instrument, assigning all of **Seller’s** right, title and interest in and to the Marks to Buyer;

NOW, THEREFORE, for valuable consideration set forth in the Asset Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Seller and Buyer agree as follows:

1. Seller hereby assigns, transfers and conveys to Buyer all of its right, title and interest in and to the Marks, including any and all present and future registrations, applications, and/or common law rights for the Marks throughout the world, together with all of the goodwill of **Seller’s** business symbolized by or associated with the Marks, and any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto including damages and payments for past, present or future infringements.

2. This Trademark Assignment is subject to the terms and conditions of the Asset Purchase Agreement and this Trademark Assignment shall not be deemed to limit, enlarge or extinguish any obligation of Seller or Buyer under the Asset Purchase Agreement, all of which obligations shall survive the delivery of this Trademark Assignment in accordance with the terms of the Asset Purchase Agreement, and that to the extent there is any conflict between this Trademark Assignment and the terms and conditions of the Asset Purchase Agreement, the Asset Purchase Agreement shall control.

3. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.



NOW, THEREFORE, in consideration of the premises and the mutual representations, warranties, covenants and undertakings contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and incorporating the above Recitals, the parties hereto, intending to be legally bound, agree as follows:

AGREEMENT

1. Assignment. Effective as of the Effective Date, Assignor does hereby sell, assign, transfer and convey to Assignee the entire right, title and interest in and to all of the Intellectual Property Assets, including but not limited to and any and all present or future continuations, divisions, renewals, extensions of the foregoing throughout the world, and any and all present and future common law rights associated with or arising in connection with any of the foregoing throughout the world, for Assignee's use and enjoyment, and including the right to sue for and collect damages by reason of past, present and future infringement and the goodwill of any business and the operations of any business associated with the Intellectual Property Assets, as fully and entirely as the same would have been held by Assignors had the General Assignment and this Assignment not been made, and Assignee does hereby accept such assignments, transfers and conveyances as of the Effective Date.

2. Successors and Assigns. Except as otherwise provided in this Assignment, the rights and obligations of the parties hereunder will be binding upon and inure to the benefit of their respective successors and assigns.


3. Governing Law. This Assignment will be governed by and construed in accordance with the laws of the State of California, without giving effect to that body of laws pertaining to conflict of laws.
