**NOTICE OF ASSIGNMENT OF SECURITY INTEREST
(INTELLECTUAL PROPERTY)**

This **NOTICE OF ASSIGNMENT OF SECURITY INTEREST (INTELLECTUAL PROPERTY)** (this "Notice"), dated as of May 15, 2019 (the "Effective Date"), is entered into among **REGIONS BANK** ("Regions"), **BANK OF AMERICA, N.A.** ("Bank of America"), and **SHELBY GROUP INTERNATIONAL, INC.**, a Tennessee corporation (the "Borrower").

WHEREAS, the Borrower, the Lenders, and Regions, in its capacity as the Agent for the Lenders, are parties to that certain Fourth Amended and Restated Loan and Security Agreement, dated as of June 28, 2013 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Loan Agreement");

WHEREAS, pursuant to the Loan Documents (as defined in the Loan Agreement), the Borrower granted to Regions a security interest in certain collateral;

WHEREAS, Regions and the Borrower entered into the Patent Assignment of Security and Trademark Assignment of Security as identified on Schedule A attached hereto (the "IP Security Agreements").

WHEREAS, the IP Security Agreements were recorded with the United States Patent and Trademark Office as identified on Schedule A attached hereto; and

WHEREAS, pursuant to that certain Sale and Assignment Agreement dated as of the Effective Date entered into by and among Regions, Bank of America and the Borrower (the "Sale and Assignment Agreement") Regions has sold, transferred and assigned to Bank of America all of Regions' interest as Agent and Lender in and to the assets, and under documents described therein, including the IP Security Agreements, on the terms and subject to the conditions set forth therein.

NOW, THEREFORE, IN CONSIDERATION of the agreements, provisions and covenants herein contained, the parties hereto hereby agree as follows:

1. Defined Terms. Capitalized terms used herein without definition shall have the meanings attributed to such terms in the Sale and Assignment Agreement or the Loan Agreement, as applicable.

2. Assignment of Interests. Pursuant to the terms and conditions set forth in the Sale and Assignment Agreement, Regions assigned any interests it may have in the Collateral and the Security Documents, and any Liens it holds under the Security Documents, including without limitation the IP Security Agreements and the Collateral scheduled on the IP Security Agreements identified on Schedule A attached hereto, to Bank of America. Nothing herein shall be deemed to terminate, interrupt, or impair the continuity of the security interest in and to the Collateral granted to Regions, in its capacity as the Agent, including the IP Security Agreements and the Collateral scheduled on the IP Security Agreements identified on Schedule A attached hereto, which security interest is assigned to Bank of America.


3. Incorporation. All terms set forth in the Sale and Assignment Agreement are hereby incorporated herein by reference with the same force and effect as though fully set forth herein. To the extent that the terms set forth herein are inconsistent with the terms of the Sale and Assignment Agreement, the terms set forth in Sale and Assignment Agreement shall control. Without limiting the generality of the foregoing, Regions does not make and hereby specifically disclaims, any and all warranties or representations concerning the validity, legality or enforceability of any of the assets assigned pursuant to the Sale and Assignment Agreement; the validity, perfection, priority or extent of

any liens in favor of Regions; the existence, location, quantity or value of any collateral; the solvency, financial condition or business prospects of the Borrower; or the collectibility of any of the obligations assigned. The sale of assets described in the Sale and Assignment Agreement shall be without recourse to Regions, except for any actual damages proximately caused by Regions' breach of any of its specific representations and warranties set forth in Section 6 of the Sale and Assignment Agreement.




