TERMINATION AND RELEASE OF SECOND LIEN NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECOND LIEN NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of June 3, 2019 (this "Termination and Release") from DEUTSCHE BANK TRUST COMPANY AMERICAS, having a principal place of business at 60 Wall Street New York, New York 10005, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties and KKR LOAN ADMINISTRATION SERVICES LLC, having a principal place of business at 9 West 57th Street New York, New York 10019, as administrative agent (in such capacity, the "Administrative Agent") for the banks and other financial institutions (collectively, the "Lenders") to SOUTHERNCARLSON, INC., a Delaware corporation, NORTHECOMM, LLC, a Delaware limited liability company, and INTERCHANGE BRANDS, LLC, a Nebraska limited liability company, each having a principal place of business at 10840 Harney Street, Omaha, NE 68154 (each a "Grantor" and collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Credit Agreement, dated as of March 29, 2018 (as amended from time to time, the "Second Lien Credit Agreement"), among Fastener Acquisition, Inc., a Delaware corporation (the "Parent Borrower"), the Subsidiary Borrowers from time to time party thereto (together with the Parent Borrower, the "Borrowers" and each a "Borrower"), the Collateral Agent, the Administrative Agent and the Lenders, the Lenders have severally agreed to make extensions of credit (collectively, the "Loans") to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Second Lien Credit Agreement, the Grantors, the Parent Borrower, Fastener Midco, Inc., a Delaware corporation (together with any successor in interest thereto, "Holding"), and certain Subsidiaries of the Parent Borrower from time to time party thereto have executed and delivered a Second Lien Guarantee and Collateral Agreement, dated as of March 29, 2018 (as amended from time to time, the "Second Lien Guarantee and Collateral Agreement"), in favor of the Collateral Agent and the Administrative Agent (collectively, the "Agents");

WHEREAS, pursuant to the Second Lien Guarantee and Collateral Agreement, each Grantor granted to the Collateral Agent and the Administrative Agent, for the benefit of the Secured Parties, a security interest (the "Security Interest") in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Second Lien Notice and Confirmation of Grant of Security Interest in Trademarks dated March 29, 2018 (the "<u>Trademark Security Agreement</u>") was recorded in the Trademark Division of the United States Patent and Trademark Office on April 10, 2018 at Reel 6342 and Frame 0556; and

WHEREAS, the Agents now desire to terminate and release the entirety of the Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agents hereby state as follows:

Section 1. <u>Definitions</u>. Unless otherwise defined herein, terms defined in this Termination and Release and used herein have the meaning given to them in the Trademark Security Agreement, the Second Lien Credit Agreement or the Second Lien Guarantee and Collateral Agreement, as applicable. The term "<u>Trademark Collateral</u>", as used herein, shall mean all of the Grantors' right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on <u>Schedule A</u> hereto), and to the extent not otherwise included, all Proceeds and products of any and all of the Trademarks.

Section 2. Release of Security Interest. The Agents hereby release, discharge, terminate and cancel all of their Security Interest in the Trademark Collateral, and any right, title or interest of the Agents in such Trademark Collateral shall hereby cease and become void. If and to the extent that the Agents have acquired any right, title or interest in and to the Trademark Collateral, without representation or warranty of any kind, hereby re-transfer, re-convey, and re-assign such right, title or interest to the Grantors.

Section 4. <u>Further Assurances.</u> The Agents hereby agree to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby. The Agents hereby authorize and request that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Termination and Release.

Section 5. <u>Governing Law.</u> This Termination and Release shall be governed by, and construed in accordance with, the laws of the State of New York.
