ABL NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

THIS ABL NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Agreement"), dated as of May 31, 2019 is made by US Foods, Inc., E & H Distributing, LLC and Fresh Unlimited, Inc. (each, a "Grantor") in favor of Wells Fargo Bank, National Association, as the Collateral Agent (as defined below) for the several banks and other financial institutions (the "Lenders") that are parties to the ABL Credit Agreement, dated as of May 31, 2019 (as amended, amended and restated, waived, supplemented or otherwise modified from time to time, together with any agreement extending the maturity of, or restructuring, refunding, refinancing or increasing the Indebtedness under such agreement or successor agreements, the "ABL Credit Agreement"), among US Foods, Inc. (the "Parent Borrower"), Wells Fargo Bank, National Association, as the collateral agent (in such capacity, together with its successors and assigns, the "Collateral Agent") for the benefit of the Secured Parties, and the other parties party thereto.

WHEREAS, pursuant to the ABL Credit Agreement, the Lenders have severally agreed to make extensions of credit to the Parent Borrower upon the terms and conditions set forth therein;

WHEREAS, in connection with the ABL Credit Agreement, the Grantors and certain Subsidiaries of the Parent Borrower executed and delivered an ABL Guarantee and Collateral Agreement, dated as of May 31, 2019), in favor of the Collateral Agent (as amended, restated, supplemented, waived or otherwise modified from time to time, the "ABL Guarantee and Collateral Agreement");

WHEREAS, pursuant to the ABL Guarantee and Collateral Agreement, the Grantors granted to the Collateral Agent a security interest in its Intellectual Property, including any Intellectual Property acquired by the Grantors after the date thereof, including Trademarks; and

WHEREAS, the Grantors have duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make extensions of credit to the Grantors on the terms and subject to the conditions of the ABL Credit Agreement the Grantors agrees, for the benefit of the Collateral Agent, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the ABL Credit Agreement and the ABL Guarantee and Collateral Agreement, as applicable.

SECTION 2. Confirmation of Security Interest. The Grantors hereby confirm that pursuant to the ABL Guarantee and Collateral Agreement, subject to existing licenses to use the Trademarks granted by the Grantors in the ordinary course of their

business, they granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Trademarks of the Grantors (including, without limitation, those items listed on Schedule A hereto) and to the extent not otherwise included, all Proceeds and products of any and all of the Trademarks, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Secured Obligations of the Grantors, except that no security interest is or will be granted pursuant thereto in any right, title or interest of the Grantors under or in any Trademark Licenses with Persons other than the Parent Borrower, a Subsidiary of the Parent Borrower or an Affiliate thereof, for so long as, and to the extent that, the granting of such a security interest pursuant thereto would result in a breach, default or termination of such Trademark Licenses.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantors for the purpose of recording the security interest granted pursuant to the ABL Guarantee and Collateral Agreement with the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the ABL Guarantee and Collateral Agreement. The ABL Guarantee and Collateral Agreement (and all rights and remedies of the Lenders thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. The Grantors do hereby further acknowledge and affirm that the rights and remedies of the Lenders with respect to the security interest in the Trademarks are fully set forth in the ABL Credit Agreement and the ABL Guarantee and Collateral Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.




