RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Release of Intellectual Property Security Agreement (this "<u>Trademark Release</u>") is made with reference to the Trademark Security Agreement dated July 13, 2009 (the "<u>Trademark Security Agreement</u>") by and between Sun Market Dining, LLC (f/k/a Sun Market Dining Reserves, LLC ("<u>Agent</u>")) and Boston Market Corporation, a Delaware corporation ("Grantor").

WHEREAS Grantor and Agent entered into that certain Security Agreement dated as of March 21, 2008 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"); capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement, as applicable).

WHEREAS, pursuant to the Security Agreement, the Grantor and Agent entered into the Trademark Security Agreement, in each case, pursuant to which Grantor granted a continuing security interest in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Exhibit A hereto.

WHEREAS the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 29, 2009, Reel 004034 at Frame 0259.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

- 1. Agent hereby releases its continuing security interest in all of Grantor's right, title and interest in and to the following, whether now owned or hereafter acquired or arising (collectively the "<u>Trademark Collateral</u>"):
 - (i) all of Grantor's Trademarks including those Trademarks referred to on Exhibit A;
- (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (c) all produces and proceeds (as the term is defined in the code) of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement of any Trademark, including the right to receive damages and (ii) injury to the goodwill associated with any Trademark.
- 2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademark Collateral, and authorizes the recordation of this Trademark Release with the United States Patent and Trademark Office at the expense of the Grantor.
- 3. Agent hereby acknowledges and agrees that the Guaranty and Security Agreement and the Trademark Security Agreement has been terminated and that all of the rights and interests of Agent thereunder have been terminated, including, without limitation, all of the rights and interests of Agent in and to the Trademark Collateral.
