TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

Termination and Release of Security Interest in Trademarks, dated as of May 30, 2019 (this "<u>Termination and Release</u>"), by U.S. Bank, National Association, in its capacity as collateral agent pursuant to the Indenture ("<u>Collateral Agent</u>") in favor of TRAVELPORT, LP and TRAVELPORT INC. (each a "<u>Grantor</u>" and collectively, the "<u>Grantors</u>").

WHEREAS, Grantors are party to that certain Security Agreement dated as of March 16, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Collateral Agent pursuant to which the Grantors executed and delivered that certain Trademark Security Agreement (as defined below);

WHEREAS, pursuant to the Trademark Security Agreement dated as of March 16, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "<u>Trademark Security Agreement</u>"), Grantors granted to the Collateral Agent for the benefit of the Secured Parties a security interest in and to all of its right, title and interest in, to and under all Collateral (as defined below) (the "<u>Security Interest</u>"), which Security Interest was recorded with the United States Patent and Trademark Office on March 16, 2018 at Reel/Frame 6293/0605;

WHEREAS, "<u>Collateral</u>" means (excluding any Excluded Assets) the Grantors' registered Trademarks and Trademarks with respect to which applications are pending listed on Schedule I attached hereto; and

WHEREAS, the Grantors desire that the Collateral Agent terminate, cancel, release and discharge fully its Security Interest.

NOW, THEREFORE, in consideration of the mutual conditions and agreements set forth in the Security Agreement, the Trademark Security Agreement and this Termination and Release, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

- Section 1. <u>Defined Terms</u>. Unless otherwise defined herein, terms defined in the Security Agreement or Trademark Security Agreement, as applicable, and used herein have the meaning given to them in the Trademark Security Agreement or the Security Agreement, as applicable.
- Section 2. <u>Release of Security Interest</u>. In connection with the full redemption of the notes and the satisfaction and discharge of the Indenture in accordance with Section 12.2(a) of the Indenture, the Collateral Agent hereby (a) terminates the Trademark Security Agreement, (b) terminates, cancels, releases and discharges fully any and all security interests it has in and to the Collateral, including the Security Interest and (c) reassigns all right, title and interest it may have in, to or under the Collateral to the Grantors, including all goodwill associated therewith.
- Section 3. <u>Recordation</u>. The Collateral Agent hereby authorizes the Grantors, or the Grantors' authorized representative, to record this Termination and Release with the United States Patent and Trademark Office.

Section 4. <u>Further Assurances</u>. At the Grantors' sole cost and expense, the Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.

Section 5. <u>Governing Law.</u> THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK. The provisions of Section 13.8 (Governing Law) and Section 13.10 (Waivers of Jury Trial) of the Indenture are incorporated herein by reference, *mutatis mutandis*, as if the same were set forth herein in full.

Section 6. <u>Counterparts</u>. This Termination and Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Termination and Release by signing and delivering one or more counterparts.
