## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of June 14, 2019 (the “Effective Date”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION (as successor collateral agent to THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A.), in its capacity as the Collateral Agent (the “Collateral Agent”) pursuant to the Collateral Agency Agreement dated as of June 12, 2013, as amended by the Supplement to the Collateral Agency Agreement dated as of January 9, 2018, and the Agreement of Resignation, Appointment and Acceptance dated as of February 8, 2018 (collectively, the “Collateral Agency Agreement”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain Security Agreement, dated as of June 12, 2013, by and among the Collateral Agent, the Grantors and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered (i) a Grant of Security Interest in United States Trademarks, dated as of June 12, 2013 (as may be amended, supplemented, restated, or otherwise modified from time to time), (ii) a Grant of Security Interest in United States Trademarks, dated as of December 29, 2016 (as may be amended, supplemented, restated, or otherwise modified from time to time) and other similar grants of security interest from time to time (each, a “Trademark Security Agreement”, and collectively, the “Trademark Security Agreements”), for recording with the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:


1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the relevant Trademark Security Agreement, as applicable.
2. Release. The Collateral Agent, without recourse representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the registered Trademarks and Trademarks with respect to which applications for registration are pending listed on Schedule I attached hereto (the “Trademark Collateral”). If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral the Collateral Agent, without recourse representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
3. Termination. The Collateral Agent, without recourse representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
4. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
5. Concerning the Collateral Agent. Wilmington Trust, National Association is executing this Release solely in its capacity as successor Collateral Agent under the Collateral Agency Agreement, and in acting hereunder shall be entitled to all of the rights, privileges, immunities and indemnities

granted to the Collateral Agent in the Collateral Agency Agreement as if such rights, privileges, immunities and indemnities were set forth herein.





