GRANT OF SECURITY INTEREST IN TRADEMARKS

This Grant of Security Interest in Trademarks and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Agreement shall be governed by, and construed in accordance with, the law of the State of New York.
