TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of July 1, 2019, by each of the entities listed on the signature pages hereof (each an "Obligor" and, collectively, the "Obligors"), in favor of Wells Fargo Bank, N.A., as administrative agent for the Secured Parties (in such capacity, the "Administrative Agent").

WITNESSETH:

WHEREAS, pursuant to the Security and Pledge Agreement dated as of July 1, 2019 (as the same may be amended, modified, extended or restated from time to time, the "<u>Agreement</u>") by and among the Obligors party thereto and the Administrative Agent, the Obligors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Defined Terms

Unless otherwise defined herein, terms defined in the Agreement and used herein have the meaning given to them in the Agreement.

2. Grant of Security Interest in Trademark Collateral

Each Obligor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of such Obligor, hereby mortgages, pledges and hypothecates to the Administrative Agent for the benefit of the Secured Parties, and grants to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Obligor (the "Trademark Collateral"):

- (a) all of its Trademarks and Trademark Licenses to which it is a party (other than any Excluded Property), including, without limitation, those referred to on Schedule I hereto;
 - (b) all reissues, renewals or extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (d) all Proceeds of the foregoing, including, without limitation, any claim by Obligor against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

3. Security Agreement

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the Agreement and each Obligor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
