WHEREAS, pursuant to the (i) Trademark Security Agreement, dated as of April 8, 2014, and recorded with the U.S. Patent and Trademark Office on April 11, 2014 at Reel/Frame 5258/0510, by and among Jones Parent LLC, a Delaware limited liability company, Jones Holdings LLC, a Delaware limited liability company, Jones Apparel (US) LLC, a New York limited liability company, Moda Nicola International LLC, a Delaware limited liability company, and Lienholder, (ii) Trademark Security Agreement, dated as of April 8, 2014, and recorded with the U.S. Patent and Trademark Office on April 14, 2014 at Reel/Frame 5259/0468, by and among Jasper Parent LLC, a Delaware limited liability company (“Jasper”), Nine West Holdings, Inc., a Delaware corporation (“Nine West”), One Jeanswear Group, Inc., a New York corporation (“Jeanswear”), Nine West Development LLC, a Delaware limited liability company (“Development”), and Lienholder, (iii) Trademark Security Agreement, dated as of January 16, 2015, and recorded with the U.S. Patent and Trademark Office on January 16, 2015 at Reel/Frame 5442/0822, between Kasper Group LLC (“Kasper” and, together with Jasper, Nine West, Jeanswear, and Development, the “Grantors”) and Lienholder, (iv) Trademark Security Agreement, dated as of March 2, 2015, between Development and Lienholder, and recorded with the U.S. Patent and Trademark Office on April 7, 2015 at Reel/Frame 5493/0726 (v) Trademark Security Agreement, dated as of May 13, 2015 (the “2015 Security Agreement”), and recorded with the U.S. Patent and Trademark Office on May 21, 2015 at Reel/Frame 5521/0272, by and among Jeanswear, Development and Lienholder, (vi) Trademark Security Agreement, dated as of January 27, 2017, between Kasper and Lienholder, and recorded with the U.S. Patent and Trademark Office on January 30, 2017 at Reel/Frame 5976/0359 (vii) Trademark Security Agreement, dated as of April 28, 2017 (the “2017 Security Agreement”), and recorded with the U.S. Patent and Trademark Office on May 3, 2017 at Reel/Frame No. 6048/0628, by and among Jeanswear, Development, and Lienholder, and (viii) the Trademark Security Agreement, dated as of April 11, 2018 (together with the 2014 Security Agreement, the 2015 Security Agreement, and the 2017 Security Agreement, the “Security Agreement”), and recorded with the U.S. Patent and Trademark Office on April 12, 2018 at Reel/Frame No. 6340/0754, by and among Kasper, Development, Jeanswear, and Lienholder, the Grantors have granted the Lienholder a lien on and continuing security interest in, all of their right, title and interest in, to and under the United States trademarks set forth on Schedule A attached hereto and all of the goodwill of the business connected with the use of, and symbolized by such trademarks (collectively, the “Trademarks”);

NOW, THEREFORE, the Lienholder, at the Grantors’ sole cost and expense, hereby terminates, cancels, discharges, and releases its Lien on, and continuing security interest in, the Trademarks and all of the goodwill of the business connected with the use of, and symbolized by


