**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

June 28, 2019

**WHEREAS, PIRAMAL CRITICAL CARE, INC.**, a Delaware corporation (the “**Grantor**”) granted a security interest to **HSBC BANK USA, NATIONAL ASSOCIATION**, as administrative agent (in such capacity, together with its successors and assigns, the “**Agent**”) in and a lien upon those certain trademarks as set forth in a certain Trademark Security Agreement dated as of April 8, 2016 by the Grantor in favor of the Agent (the “**Agreement**”; all initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Agreement), which was recorded in the United States Patent and Trademark Office on April 21, 2016 at Reel 5782, Frame 0465; and

**WHEREAS**, the Grantor has requested that the Agent release and reassign to Grantor its interest in the Trademark Collateral, including such trademarks identified in **Schedule A** hereto and made a part hereof.

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby:

1. Releases, terminates and discharges all liens in the Trademark Collateral, including the trademarks identified in **Schedule A** hereto, without recourse or representation or warranty, express or implied of any kind.
2. Authorizes and requests that the Commissioner for Trademarks at the United States Patent and Trademark Office note and record the existence of the release hereby given.
3. Agrees that it shall, at the Grantor’s sole cost and expense and at any of the Grantor’s reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.
