NOTICE OF TRANSFER OF SECURITY INTEREST IN TRADEMARKS

July 1, 2019

WHEREAS, ZIH CORP. ("ZIH") and Zebra Technologies Corporation ("ZTC") are party to a Security Agreement dated as of October 27, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among ZIH and ZTC, the other Grantors party thereto and JPMorgan Chase Bank, N.A., as the Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent"), pursuant to which ZIH granted a security interest to the Collateral Agent (for the benefit of the Secured Parties) in the Trademark Collateral (as defined below);

WHEREAS, in connection with the Security Agreement, ZIH entered into and executed a Trademark Security Agreement dated as of October 27, 2014, by and among ZIH, Morgan Stanley Senior Funding, Inc. (as predecessor-in-interest to the Collateral Agent) and the other Grantors party thereto which was recorded with the United States Patent and Trademark Office (the "USPTO") on October 29, 2014 at Reel/Frame No. 5390/0497 (the "2014 Security Agreement");

WHEREAS, in connection with the Security Agreement, ZIH entered into and executed a Trademark Security Agreement dated as of September 7, 2017, by and among ZIH and the Collateral Agent which was recorded with the USPTO on October 25, 2017 at Reel/Frame No. 6190/0231 (the "2017 Security Agreement," and collectively with the 2014 Security Agreement, the "Trademark Security Agreements");

WHEREAS, ZIH merged with and into ZTC, effective as of December 20, 2018 (the "Merger"), via a Certificate of Ownership recorded with the USPTO on January 22, 2019 at Reel/Frame No. 6532/0006, pursuant to which ownership of the Trademark Collateral passed from ZIH to ZTC; and

WHEREAS, ZTC and the Collateral Agent (each, a "Party," and collectively, the "Parties") wish to acknowledge that, by virtue of the Merger and transfer of ownership of the Trademark Collateral from ZIH to ZTC, the security interest granted to the Collateral Agent (for the benefit of the Secured Parties) in such Trademark Collateral by the Security Agreement and the Trademark Security Agreements is still in effect.

Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meanings given to them in the Security Agreement.

NOW, THEREFORE, in consideration of the foregoing and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted to the Collateral Agent (for the benefit of the Secured Parties) pursuant to the Security Agreement and the Trademark Security Agreements, ZTC hereby acknowledges the existence of an ongoing security interest in favor of the Collateral Agent (for the benefit of the Secured Parties) in all of ZTC's right, title and interest in and to the following property, in each case that was formerly owned by ZIH and was transferred to ZTC pursuant to the Merger (collectively, the "Trademark Collateral"), other than Excluded Property:

- (i) all trademarks, service marks, designs, logos, indicia of origin, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto (including, without limitation, the trademarks set forth on <u>Schedule A</u> annexed hereto) (collectively, the "**Trademarks**");
- (ii) all goodwill of such ZIH's business symbolized by the Trademarks associated therewith;
- (iii) all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not the Collateral Agent is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral; and
- (iv) the right to sue or otherwise recover for any past, present and future infringement, dilution, misappropriation, or other violation or impairment of any of the foregoing.

Notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include or the security interest granted under Section 1(a) of the Security Agreement attach to any "intent-to-use" trademark applications for which a statement of use or an amendment to allege use has not been filed and accepted by the USPTO (but only until such statement or amendment is filed and accepted by the USPTO), and solely to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of, or void or cause the abandonment or lapse of, such application or any registration that issues from such intent-to-use application under applicable U.S. law.

ZTC does hereby further acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral are more fully set forth in the Security Agreement. Section 1 of the Security Agreement is hereby incorporated by reference. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THEREOF TO THE EXTENT SUCH PRINCIPLES WOULD CAUSE THE APPLICATION OF THE LAW OF ANOTHER STATE, EXCEPT TO THE EXTENT THAT THE UCC PROVIDES THAT THE PERFECTION OF THE SECURITY INTEREST HEREUNDER, OR REMEDIES HEREUNDER, IN RESPECT OF ANY PARTICULAR COLLATERAL ARE GOVERNED BY THE LAWS OF A JURISDICTION OTHER THAN THE STATE OF NEW YORK, IN WHICH CASE THE LAWS OF SUCH JURISDICTION SHALL GOVERN WITH RESPECT TO THE PERFECTION OF THE SECURITY INTEREST IN, OR THE REMEDIES WITH RESPECT TO, SUCH PARTICULAR COLLATERAL.

This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument; signature pages may be detached from multiple separate counterparts and attached to a single counterpart so that all signature pages are physically attached to the same document. Delivery of an executed signature page to this Agreement by facsimile transmission or other electronic communication shall be as effective as delivery of a manually signed counterpart of this Agreement.
