## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT is entered into as of the last date of signature below by and between NOVIMMUNE SA (“Assignor”), a corporation organized under the laws of Switzerland, located at 14 ch. des Aulx, 1228 Plan-les-Ouates Geneva, Switzerland, and EMACO SA (“Assignee”), a corporation organized under the laws of Switzerland, located at 14 ch. des Auls, 1228 Plan les Ouates, Geneva, Switzerland (collectively, the “Parties”).

**WHEREAS**, the Assignor is the owner of the trademarks and corresponding trademark applications and registrations listed in Schedule A attached hereto, including all common law and statutory rights associated therewith (collectively, the “Trademarks”); and

**WHEREAS**, Assignor and Assignee are parties to that certain Asset Contribution Agreement dated June 12, 2019 (the “Contribution Agreement”);

**WHEREAS**, in connection with the Contribution Agreement, Assignor desires to assign all of the Trademarks and goodwill associated therewith to Assignee; and

**WHEREAS**, the Assignee wishes to acquire all of Assignor’s rights, title, and interest throughout the world in and to the Trademarks;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:


1. Assignor hereby irrevocably assigns, transfers, conveys and delivers to the Assignee all rights, title, and interest, in the United States and throughout the world, in and to the Trademarks, along with all goodwill associated therewith, and all rights pertaining thereto, including, the right to maintain and prosecute trademark registrations and applications for any of the Trademarks and the right to sue and recover damages for past, present and future infringement of any of the Trademarks.

2. From time to time after the date hereof, and for no further consideration, Assignor and Assignee shall execute, acknowledge and deliver such assignments, transfers, consents, assumptions and other documents and instruments and take such other actions as may reasonably be necessary to consummate the transactions contemplated hereby. Assignor shall ensure that copies of all correspondence in relation to the Trademarks that it, or its agents, receive (including any renewal advice or other notification received from any government agency) are promptly delivered to Assignee.


