RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of August 17, 2018 (this “Release”), is made by EVEREST REINSURANCE COMPANY (“Everest”), in connection with that certain Security Agreement, dated as of February 6, 2017, by and among Apollo Education Group, Inc., an Arizona corporation (the “Company”), the Subsidiaries of the Company party thereto and Everest (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”). Capitalized terms used but not defined herein shall have the meanings set forth in the Security Agreement.

W I T N E S S E T H:

WHEREAS, in connection with the Security Agreement, the Company, the other Debtors party thereto and Everest entered into that certain Intellectual Property Security Agreement, dated as of February 6, 2017, which was recorded with the United States Patent and Trademark Office (“USPTO”) on February 10, 2017 at Reel No. 5985, Frame No. 0686 (the “IP Security Agreement”), and collectively with the Security Agreement, the “Security Agreements”);

WHEREAS, pursuant to the Security Agreements, as security for the payment and performance, as applicable, in full of the Liabilities, the Company assigned and pledged to Everest, its successors and permitted assigns a security interest in all of its right, title and interest in and to all of the IP Collateral (as defined in the IP Security Agreement), including but not limited to the patents and patent applications set forth on Schedule I attached hereto, the copyright registrations set forth on Schedule II attached hereto and the trademark registrations and applications set forth on Schedule III hereto, together with the goodwill symbolized thereby;

WHEREAS, the Company desires that Everest terminate and release any and all right, title and interest it may have in the IP Collateral pursuant to the Security Agreements, and Everest has agreed to do so; and

WHEREAS, Everest has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Everest agrees, for the benefit of the Company, as follows:

SECTION 1. *Release of Security Interest in IP Collateral.* Everest does hereby terminate, release, relinquish and discharge its security interest in, and right of setoff against, all right, title and interest in and to the IP Collateral, and hereby reassigns and transfers to the Company all right, title and interest that Everest may have in the IP Collateral, including but not limited to the patents and patent applications set forth on Schedule I attached hereto, the copyright registrations set forth on Schedule II attached hereto and the trademark registrations and applications set forth on Schedule III hereto, together with the goodwill symbolized thereby.

SECTION 2. *Further Assurances.* Everest hereby authorizes the Company, its successors and assigns, and their respective designees (i) to record this Release with the USPTO and/or U.S. Copyright Office, (ii) file UCC financing statement amendments or terminations, as applicable, in order to memorialize the release of the security interest of Everest in the IP Collateral and (iii) otherwise record or file this Release in applicable governmental offices or agencies. Everest further authorizes and requests that the USPTO Commissioner for Trademarks, the U.S. Copyright Office Register of Copyrights and any other necessary United States government officer, record this Release. Everest further agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or its successors, assigns or their respective designees) reasonably request, at the Company's sole cost and expense, in order to confirm this Release and the Company's right, title and interest in, to and under the IP Collateral.

SECTION 3. *Governing Law.* This Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to the conflicts of law provisions thereof.
