TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT ("Trademark Security Agreement"), dated as of June 18, 2019, is made by BUCK KNIVES, INC., a Nevada corporation ("Debtor"), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION ("Bank"), as a secured party under the Security Agreement (as defined below).

WHEREAS, Debtor and Bank have entered into that certain amended and restated Security Agreement: Business Assets dated as of April 23, 2018 (the "Security Agreement"), in connection with that certain Credit Agreement, dated as of April 23, 2018, as amended by that certain First Amendment to Credit Agreement dated as of August 1, 2018, that certain Forbearance Agreement and Amendment dated as of April 2, 2019, that certain Third Amendment to Credit Agreement dated as of May 1, 2019, and that certain Fourth Amendment to Credit Agreement dated as of June 18, 2019 (as so amended and as amended, modified, or supplemented from time to time, the "Credit Agreement").

WHEREAS, under the terms of the Security Agreement, Debtor has granted to the Bank a security interest in, among other property, certain general intangibles of Debtor and has agreed to execute and deliver this Trademark Security Agreement for recording with certain governmental authorities, including, but not limited to, the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Debtor agrees with Bank as follows:

- 1. <u>Grant of Security</u>. Debtor hereby grants and transfers to Bank a security interest in all of Debtor's right, title and interest in, to and under the following (the "Trademark Collateral"):
- (a) general intangibles, including, without limitation, all trademarks, trade names, service marks, and all designs and general intangibles of like nature together with the goodwill connected with the use of and symbolized thereby, now existing or hereafter adopted or acquired, all registrations and recordings thereof, including all applications, registrations, and recordings in the U.S. Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any foreign country or political subdivision thereof, including those set forth on Schedule A attached hereto, and
- (b) all additions, renewals and replacements of the foregoing, including, without limitation, all proceeds thereof, including whatever is acquired when any of the Trademark Collateral or proceeds thereof are sold, licensed, or otherwise disposed of, whether such disposition is voluntary or involuntary and whatever is collected on or distributed on account thereof, including, without limitation, (i) all rights to payment however evidenced, (ii) all goods returned by or repossessed from Debtor's customers, (iii) rights arising out of the Trademark Collateral, (iv) claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right, but not obligation, to sue for such legal and equitable relief and to collect,

or otherwise recover, any such damages to, the Trademark Collateral, (v) insurance payable by reason of the loss or infringement of rights in, or damage to, the Trademark Collateral, (vi) returned insurance premiums, and (vii) all rights to payment with respect to any claim or cause of action affecting or relating to any of the foregoing.

- 2. <u>Recordation</u>. Debtor authorizes the Commissioner for Trademarks and any other government officials to record and register this Trademark Security Agreement upon request by Bank.
- 3. <u>Loan Documents</u>. This Trademark Security Agreement has been entered into pursuant to and in conjunction with the Security Agreement, which is hereby incorporated by reference. The provisions of the Security Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of Bank with respect to the Trademark Collateral are as provided by the Credit Agreement, the Security Agreement and related documents, and nothing in this Trademark Security Agreement shall be deemed to limit such rights and remedies.
- 4. <u>Execution in Counterparts</u>. This Trademark Security Agreement may be executed in counterparts, each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Trademark Security Agreement in electronic format shall be effective as delivery of a manually-executed counterpart of this Trademark Security Agreement.
- 5. <u>Successors and Assigns</u>. This Trademark Security Agreement shall be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.
- 6. <u>Governing Law.</u> THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED UNDER AND GOVERNED BY THE LAWS OF THE STATE OF WASHINGTON, EXCEPT TO THE EXTENT THAT THE APPLICABILITY OF ANY SUCH LAWS MAY NOW OR HEREAFTER BE PREEMPTED BY FEDERAL LAW, IN WHICH CASE, SUCH FEDERAL LAW SHALL SO GOVERN AND BE CONTROLLING.
