RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of June 26, 2019, is made by BNP PARIBAS, as collateral agent (in such capacity, the "Collateral Agent"), in favor of the Grantors listed in Schedule I hereto (collectively, jointly and severally, the "Assignees").

WITNESSETH:

WHEREAS, the Assignees and the Collateral Agent are parties to (i) that certain Second Lien Guarantee and Collateral Agreement, dated as of November 19, 2013 (the "Guarantee and Collateral Agreement") and (ii) that certain Second Lien Trademark Security Agreement, dated as of November 19, 2013 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, as security for the payment or performance, as the case may be, in full of the Obligations, each Assignee assigned, pledged and granted to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest (the "Security Interest"), in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by such Assignee or in which such Assignee then had or any time in the future may have acquired any right, title or interest (other than any assets and properties excluded from the Article 9 Collateral pursuant to the Guarantee and Collateral Agreement) (collectively, the "Trademark Collateral"): (a) all trademarks, service marks, certification marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, slogans, logos, Internet domain names, other source or business identifiers, designs and general intangibles of like nature, whether statutory or common law, whether registered or unregistered, and whether established or registered in the United States of any other country or any political subdivision thereof, (b) all registrations and recordings thereof, and all applications filed in connection therewith, including in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof, including those listed on Schedule I hereto, (c) all renewals thereof, (d) goodwill connected with the use thereof and symbolized thereby, (e) all other assets, rights and interests that uniquely reflect or embody such goodwill, (f) all rights and privileges arising under applicable law with respect to the use of any of the foregoing, (g) all income, fees, royalties, damages and payments now or hereafter due and/or payable thereunder or with respect thereto, including damages, claims and payments for past, present or future infringements, dilutions or other violation thereof, (h) all rights to sue for past, present or future infringements, dilutions or other violations thereof, and (i) all rights corresponding thereto throughout the world.

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 20, 2013 at Reel/Frame No. 5180/0176; and

WHEREAS, the Assignees desire that the Collateral Agent terminate and release its lien on and Security Interest in and to all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

- 1. <u>DEFINED TERMS</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
- 2. <u>TERMINATION AND RELEASE</u>. The Collateral Agent hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its lien on and Security Interest in and to all right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed on <u>Schedule I</u> attached hereto, and reassigns and transfers to the Assignees all right, title and interest that the Collateral Agent may have in the Trademark Collateral.
- 3. <u>RECORDATION</u>. The Collateral Agent hereby authorizes the Assignees, or the Assignees' authorized representative, to record this Release with the United States Patent and Trademark Office.
- 4. <u>FURTHER ASSURANCES</u>. The Collateral Agent hereby agrees to duly execute and deliver to the Assignees any further documents and to do such other acts that the Assignees (or their respective agents or designees) reasonably request, at the Assignees' sole cost and expense, in order to confirm this Release and the Assignees' right, title and interest in the Trademark Collateral.
- 5. <u>Applicable Law</u>. THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
- 6. <u>COUNTERPARTS</u>. This Trademark Security Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this Trademark Security Agreement or any other Loan Document in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by fax transmission or by e-mail transmission shall be deemed an original signature hereto.
