**TRADEMARK ASSIGNMENT AGREEMENT (US)**

**THIS TRADEMARK ASSIGNMENT AGREEMENT** (this “Assignment”) is made and entered into as of January 2, 2019 (“Effective Date”) by and between **Spectrum Brands, Inc.**, a Delaware corporation (“Assignor”), and **Energizer Brands, LLC**, a Delaware limited liability company (“Assignee”).

**WHEREAS**, Assignor is a subsidiary of Spectrum Brands Holdings Inc., a Delaware corporation (“Seller”), and Assignee is a subsidiary of Energizer Holdings, Inc., a Missouri corporation (“Purchaser”), and Seller and Purchaser are parties to that certain Amended and Restated Acquisition Agreement, dated as of November 15, 2018 (the “Amended Agreement”); and

**WHEREAS**, pursuant to the Amended Agreement, Seller shall cause Assignor to assign to Assignee, a designated Affiliate (as defined in the Amended Agreement) of Purchaser, and Assignee shall acquire from Assignor, all Trademarks (as defined in the Amended Agreement) that constitute Transferred Assets (as defined in the Amended Agreement), in each case, together with the goodwill of the business associated therewith, including but not limited to the trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto (collectively, the “Marks”);

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, its entire right, title and interest in and to the Marks, for the United States and for all other countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any other country or under international conventions and treaties, now or hereafter in effect, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, all causes of action (either in law or in equity) relating thereto, and the right to sue, counterclaim, and recover damages for past, present or future infringement, dilution or other unauthorized use of the Marks.

Assignor hereby request the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Marks.

To the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Amended Agreement, the Amended Agreement will govern.

This Assignment and any dispute arising out of or relating to or in connection with this Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws thereof.

This Assignment may be executed in one or more counterparts, and by each of the parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same original instrument. Delivery of an executed counterpart of a signature page to this Assignment by electronic means (including portable document format) shall be as effective as delivery of a manually executed counterpart of this Assignment.


