**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of August 5, 2019 in favor of ABC Industries, Inc., an Indiana corporation ("Grantor"), by BMO Harris Bank, N.A. ("Grantee").

WHEREAS, pursuant to the terms and conditions of that certain Grant of Security Interest in United States Trademarks dated as of August 1, 2012 executed by Grantor and Grantee (the "Grant of Security Interest"), Grantor granted to Grantee a security interest in all of Grantor's right, title and interest in and to the trademark applications and registrations set forth on Schedule 1 attached hereto (collectively the "Trademarks");

WHEREAS, the Grant of Security Interest was recorded with the United States Patent and Trademark Office on August 9, 2012 at Reel/Frame 4839/0465.

WHEREAS, Grantee wishes to release its security interest in the Trademarks and reassign to Grantor all of Grantee's right, title and interest in and to the Trademarks of Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Grant of Security Interest and hereby terminates, cancels and releases any security interest it may have in the Trademarks and reassigns to Grantor any rights it may have in the Trademarks.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release. Grantor is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
