TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

TERMINATION AND RELEASE dated as of July [29], 2019, from WELLS FARGO BANK, National Association., as Collateral Agent (in such capacity and together with any successors in such capacity, the "Collateral Agent") to First Data Corporation, and each of the parties set forth on Schedule I hereto (individually, a "Grantor," and collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, dated as of August 20, 2010, in favor of the Collateral Agent for the benefit of the Secured Parties (the "Security Agreement"), Grantors pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to certain collateral (the "Security Interest");

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 20, 2010, among the Collateral Agent and Grantors (the "<u>Trademark Security Agreement</u>"), each Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the Security Interest to the Collateral Agent specifically in the Trademarks of such Grantor, including those listed on <u>Schedule II</u> attached hereto, and all Proceeds of any and all of the foregoing (collectively, the "<u>Trademark</u> Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 23, 2010 at Reel 4265 and Frame 0091.

WHEREAS, the Grantors have requested that the Collateral Agent terminate and release the entirety of its Security Interest in the Trademark Collateral, in connection with the satisfaction and discharge of the Grantors' obligations to the Secured Parties under the Trademark Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:

- 1. <u>Definitions</u>. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.
- 2. <u>Release of Security Interest</u>. The Collateral Agent hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest in the Trademark Collateral, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.
- 3. <u>Further Assurances</u>.
