## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is dated as of August 21, 2019, by Kayne Solutions Fund, L.P., in its capacity as administrative agent (in such capacity, the "Agent"). Terms defined in the Loan Agreement and Trademark Agreement referred to below and not otherwise defined herein are used herein as defined in the Loan Agreement and Trademark Agreement, as applicable.

WHEREAS, reference is made to (i) that certain Term Loan and Security Agreement dated as of September 21, 2017 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the "Loan Agreement"), by and among, among others, the Agent and TSC Apparel, LLC, an Ohio limited liability company (the "Grantor") and (ii) that certain Trademark Security Agreement, dated as of September 21, 2017 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the "Trademark Agreement"), by and among the Agent and the Grantor;

WHEREAS, under the Loan Agreement and the Trademark Agreement, the Grantor granted to the Agent a security interest in, among other things, certain Trademark Collateral (as defined in the Trademark Agreement), including, without limitation, the trademarks listed on Schedule I attached hereto, and the goodwill associated therewith or symbolized thereby, as security for certain obligations of the Grantor to the Agent;

WHEREAS, the Agent recorded the Trademark Agreement on September 21, 2017 at Reel 6158, Frame 0673 with the United States Patent and Trademark Office; and

WHEREAS, the Grantor has requested that the Agent release its security interests in the Trademark Collateral, including the trademarks listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby fully discharges, releases and terminates its security interests in and liens on the Trademark Collateral, including the trademarks listed on Schedule I hereto, and any right, title or interest of the Agent and the other Secured Parties in the foregoing under the Loan Agreement and the Trademark Agreement shall hereby cease and become void.
