Notwithstanding anything herein to the contrary, the lien and security interest granted to the Agent pursuant to or in connection with this Agreement or any other Security Document, and the exercise of any right or remedy by the Agent hereunder or thereunder in respect of the Collateral are subject to the provisions of that certain Intercreditor Agreement dated as of August 21, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the "Intercreditor Agreement"), between Bank of America, N.A., as the First Lien Agent, and Agent, as the Second Lien Agent, and acknowledged by the Obligors. In the event of any conflict between the terms of the Intercreditor Agreement and this Agreement or any other Security Document, the terms of the Intercreditor Agreement shall control.

SECOND LIEN TRADEMARK SECURITY AGREEMENT

THIS SECOND LIEN TRADEMARK SECURITY AGREEMENT, dated as of August 21, 2019 (this "<u>Agreement</u>"), is made by TSC Apparel, LLC, an Ohio limited liability company, and Ouray Sportswear, LLC, a Colorado limited liability company (together, the "<u>Grantors</u>"), in favor of FMP Agency Services, LLC, as collateral agent (in such capacity, "<u>Agent</u>"). Reference is made to the Second Lien Note Purchase and Security Agreement dated as of August 21, 2019 (as amended, supplemented or otherwise modified from time to time, the "<u>Purchase Agreement</u>"), by, among others, the Grantors, as Issuers (defined therein), the Purchasers (defined therein) from time to time party thereto and Agent.

WHEREAS, the Purchasers have agreed to purchase Notes from the Issuers subject to the terms and conditions set forth in the Purchase Agreement. The obligation of the Purchasers to purchase such Notes is conditioned upon, among other things, the execution and delivery of this Agreement.

WHEREAS, the Grantors will derive substantial benefits from such issuance and sale of Notes pursuant to the Purchase Agreement and are willing to execute and deliver this Agreement in order to induce Purchasers to purchase such Notes. Accordingly, the parties hereto agree as follows:

SECTION 1. <u>Terms.</u> Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Purchase Agreement.

SECTION 2. <u>Grant of Security Interest.</u> As security for the payment or performance, as the case may be, in full of the Obligations, each Grantor pursuant to the Purchase Agreement did, and hereby does, grant to Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all right, title and interest in, to and under any and all of the following assets now owned or at any time hereafter acquired by such Grantor or in, to or under which such Grantor now has or at any time hereafter may acquire any right, title or interest (collectively, the "<u>Trademark Collateral</u>"):

- (a) all trademarks listed on <u>Schedule I</u> hereto;
- (b) all goodwill associated therewith or symbolized thereby; and
- (c) all other assets, rights and interests that uniquely reflect or embody such goodwill.

SECTION 3. Furtherance of Interests. The security interests granted to Agent herein are granted in furtherance, and not in limitation of, the security interests granted to Agent pursuant to the Purchase Agreement and the other Financing Documents. The Grantors hereby acknowledge and affirm that the rights and remedies of Agent with respect to the Trademark Collateral are more fully set forth in the Purchase Agreement and the other Financing Documents, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Purchase Agreement, the terms of the Purchase Agreement shall govern. This Agreement is a Financing Document.

SECTION 4. <u>Counterparts</u>. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic imaging shall be effective as delivery of a manually executed counterpart of this Agreement.
