## INTELLECTUAL PROPERTY ASSIGNMENT


Gibson Brands Inc. ("Assignor") hereby agrees with Tom Oberheim ("Assignee") the following:

Upon the date of this Assignment, Assignor will no longer take any action with regard to the Assigned Trademarks or matters associated therewith, and Assignee will assume all responsibility therefor.
