**TRADEMARK SECURITY AGREEMENT**

Trademark Security Agreement (this “**Agreement**”), dated as of August 22, 2019, by Valiant Entertainment LLC, a Delaware limited liability company (“**Grantor**”), in favor of Neutrino Corp., a New York corporation (“**Secured Party**”).

WITNESSETH:

WHEREAS, Grantor is party to that certain Security Agreement, dated as of July 14, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and between Grantor and Secured Party, pursuant to which Grantor is required to execute and deliver this Agreement;

NOW, THEREFORE, in consideration of the premises and to induce Secured Party to enter into the Security Agreement, Grantor hereby agrees with Secured Party as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in this Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. Grantor hereby pledges and grants to Secured Party a security interest in and to all of its right, title and interest in, to and under all the following Collateral of Grantor (collectively, the “**Trademark Collateral**”): (i) all of Grantor’s right, title and interest in, to and under the United States trademarks, trademark registrations and applications set forth on Schedule I attached hereto together with any reissues, continuations or extensions thereof and all goodwill associated therewith, provided, however, the Trademark Collateral does not include an assignment of, and this Agreement does not assign, any Intent-To-Use Application at any time that the assignability thereof is prohibited under 15 U.S.C. §1060(a) (the “**Trademarks**”); and (ii) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any Trademarks.


SECTION 3. Security Agreement. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to Secured Party pursuant to the Security Agreement, and Grantor and Secured Party hereby acknowledge and affirm that the rights and remedies of Grantor and Secured Party with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Subject to the provisions of this Agreement and the Security Agreement, Grantor may use, license, and exploit the Trademark Collateral in any lawful manner permitted hereunder and under the Security Agreement. In the event that any provision of this Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Termination. This Agreement is made for collateral purposes only. Upon the payment in full of the Obligations, Secured Party will promptly execute and deliver to Grantor all instruments and documents and take all further action that may be necessary, or that Grantor may reasonably request, in order to terminate Secured Party’s security interest in the Trademark Collateral, including without limitation an instrument in writing in recordable form releasing Secured Party’s security interest in the Trademark Collateral under this Agreement.

SECTION 5. Counterparts. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, .pdf, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

IN WITNESS WHEREOF, Grantor has caused this Trademark Security Agreement to be executed and delivered by its duly authorized officer as of the date first set forth above.


