## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is made as of July 26, 2019, (the "Effective Date"), between Product Quest Manufacturing, LLC, a Debtor in a Chapter 7 case, (the "Assignor"), acting by and through its Trustee, C. Edwin Allman, III with an address at PO Box 5129, Winston-Salem, NC 27113 and Randob Labs Ltd., a New York corporation with a principal place of business located at 45 Quaker Avenue, STE 207, Cornwall, NY 12518 (the "Assignee").

**WHEREAS**, Assignor is the registered owner of US Registration No. 2,055,324, US Registration No. 1,742,691 and US Registration No., 0,723,274 (collectively the "Trademarks"), all depicted on Exhibit A attached hereto and incorporated herein by reference; and

**WHEREAS**, Assignor desires to contribute, transfer and assign all of its right, title and interest in and to the Trademarks to Assignee, and Assignee desires to receive same;

**NOW, THEREFORE**, in consideration of the sum of one dollar (\$1.00) and for other good and valuable consideration from Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Effective as of July 26, 2019, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns:

(a) all of Assignor's right, title and interest throughout the world in and to the Trademarks;

(b) all registrations, including without limitation US Registration No. 2,055,324, US Registration No. 1,742,691 and US Registration No., 0,723,274 registration renewals, registration extensions and applications for registration of the Trademarks that are or may be secured under the laws of the United States and all foreign countries;

(c) the full right to sue for and recover all profits recoverable from past infringement of the Trademarks, and the right to initiate suit and obtain damages and other forms of relief, both legal and equitable, arising from infringement, misappropriation or other violation whether prior to or subsequent to the Effective Date;

(d) the goodwill of the business relating to the products and services on which the Trademarks are used and for which they are registered; and

(e) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademarks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademarks.


2. Successors and Assigns. All of the foregoing shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefits of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

3. Further Assurances. Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee all of Assignor's full right, title, and interest in the Trademarks and its related property. Assignor shall promptly, upon the request of Assignee, execute each other instruments of assignment, transfer and conveyance necessary for Assignee to record the assignment made by this instrument.


