CONFIRMATORY TRADEMARK ASSIGNMENT

Assignee is the successor to the business to which the Assigned Trademarks relate.
- 2. <u>Due Authorization</u>. Assignor hereby authorizes and requests the officials of the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign jurisdiction, to record this Confirmatory Assignment and record Assignee as assignee and owner of the entire right, title and interest in, to and under the Assigned Trademarks.
- 3. <u>Governing Law.</u> This Confirmatory Assignment and all disputes arising out of or relating to this Confirmatory Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware applicable to contracts made and performed entirely within the State of Delaware without giving effect to any laws or principles of conflicts of laws of such state that would cause the laws of any other jurisdiction to apply.

4. <u>Counterparts</u>. For the convenience of the Parties, this Confirmatory Assignment may be executed in any number of counterparts, each such counterpart being deemed to be an original instrument, and all such counterparts shall together constitute one agreement.
