TRADEMARK ASSIGNMENT

WHEREAS, Angelo Risi, a Canadian citizen (hereinafter "Assignor"), adopted and used the trademark **RIVERCREST** for segmental retaining wall block system, namely, concrete retaining walls and, on October 15, 2013, obtained United States trademark Registration No. 4,417,370 for said trademark (hereinafter, collectively, referred to as the "Trademark"); and

South, Unit 10, Newmarket, Ontario, Canada L3Y 0B3 (hereinafter "Assignee"), desires to acquire all right, title and interest in and to the aforementioned Trademark, together with the goodwill of the business symbolized by such Trademark, and the business to which such Trademark pertains; and

WHEREAS, it is desired that the assignment of the Trademark and associated U.S. trademark Registration No. 4,417,370 therefor be made of record.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, on behalf of the Assignor, effective as of the earliest date of signature, below, Trustees hereby assign, transfer and convey unto Assignee all right, title and interest in and to said Trademark, together with the goodwill of the business symbolized by said Trademark and the business to which such Trademark pertains, and the U.S. trademark Registration No. 4,417,370 therefor, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and

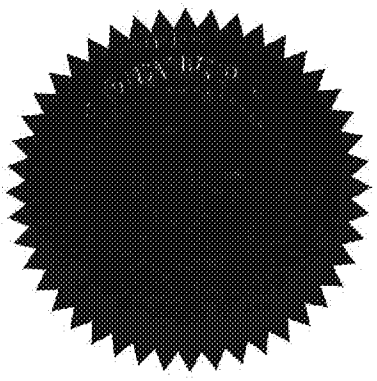

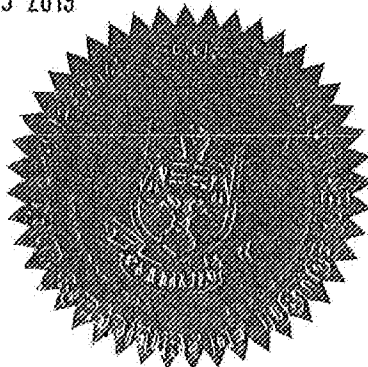
