INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment") is entered into as of September 23, 2019, by CORNERSTONE RESEARCH & DEVELOPMENT, INC., a Delaware corporation ("Transferor"), in favor of CAPSTONE NUTRITION, LLC, a Delaware limited liability company ("Transferee").

A. This Assignment is being entered into pursuant to that certain Contribution and Acceptance Agreement dated as of the date hereof between Transferor and Transferee (the "Contribution Agreement"). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed to them in the Contribution Agreement.

B. Pursuant to the Contribution Agreement, Transferor has agreed to contribute, assign, convey, transfer and deliver to Transferee, and Transferee has agreed to acquire, receive and accept from Transferor, all of Transferor's right, title and interest in and to certain registered and unregistered intellectual property material or related to, necessary for, or used in Transferor's business, including without limitation the intellectual property listed on Schedule A hereto (the "**Intellectual Property**").

NOW, THEREFORE, effective by this instrument and for good and valuable consideration, receipt of which is hereby acknowledged, Transferor hereby assigns to Transferee and its successors and assigns, without any restrictions, limitations or reservations, any and all right, title and interest of Transferor, worldwide, in and to the Intellectual Property and any and all registrations or recordations thereof, including, but not limited to, (a) the goodwill of the business symbolized by, and all benefit of any prior use of, the trademarks included in the Intellectual Property, (b) the use of the Intellectual Property in any manner, (c) any and all rights to royalties, fees, income, payments and other proceeds hereafter due or payable and to initiate claims or proceedings for past, present or future infringements of Transferor's right, title and interest in and to the Intellectual Property, and (d) any and all rights of any kind whatsoever of Transferor accruing under any of the foregoing provided by applicable law of any jurisdiction, as fully and entirely as the same would have been held and enjoyed by Transferor had this Assignment not been made.

Transferor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Transferee. Following the date hereof, upon Transferee's reasonable request and at Transferee's sole expense, Transferor shall take such steps and actions, and provide such cooperation and assistance to Transferee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Intellectual Property to Transferee, or any assignee or successor thereto. These actions may include, but are not limited to, promptly (i) unlocking the domain name(s) and providing the authorization code for the domain name(s) to Transferee; (ii) executing and/or completing such other additional documents or forms as are delivered to Transferor by

Transferee or the applicable registrar; and (iii) taking the necessary steps required by the applicable registrar to transfer the domain name(s) to Transferee.

Nothing in this Assignment is intended to provide any rights to Transferee beyond those rights expressly provided to Transferee in the Contribution Agreement. Should any term hereof be in conflict with any term of the Contribution Agreement, the terms of the Contribution Agreement shall prevail. This Assignment will bind and inure to the benefit of Assignor and Assignees and their respective successors and permitted assigns.

This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to the principles of conflicts of law thereof.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Any signature page delivered via a facsimile machine or other electronic transmission shall be binding to the same extent as an original signature page.


