RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("**Release**") is made and effective as of the Effective Time (as defined below) and granted by Wells Fargo Bank, National Association (the "**Administrative Agent**"), as administrative agent for the secured parties (the "**Secured Parties**") under the Agreement referred to below, in favor of Fossil Group, Inc., a Delaware Corporation (the "**Grantor**").

WHEREAS, the Grantor, the Administrative Agent and the lenders party thereto entered into that certain Collateral Agreement dated as of August 8, 2016 (as amended, restated, supplemented or otherwise modified from time to time) ("**2016 Agreement**") and that certain Second Amended and Restated Collateral Agreement dated as of January 29, 2018 (as amended, restated, supplemented or otherwise modified from time to time) ("**2018 Agreement**") (collectively, the "**Agreement**");

WHEREAS, in connection with the 2016 Agreement, the Grantor executed and delivered to the Administrative Agent that certain Notice of Grant of Security Interest in Trademarks by and between the Grantor and the Administrative Agent dated as of August 8, 2016 (the "**2016 Trademark Security Agreement**") and, in connection with the 2018 Agreement, the Grantor executed and delivered to the Administrative Agent that Certain Notice of Grant of Security Interest in Trademarks dated as of January 29, 2018 (the "**2018 Trademark Security Agreement**") (collectively, the "**Trademark Security Agreement**");

WHEREAS, pursuant to the Agreement and Trademark Security Agreement, the Grantor pledged and granted to the Administrative Agent for the ratable benefit of the Secured Parties a continuing security interest in and continuing lien upon the "**Trademark Collateral**" (as defined below);

WHEREAS, the 2016 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005879, Frame 0611 on September 15, 2016;

WHEREAS, the 2018 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 006273, Frame 0275 on February 14, 2018;

WHEREAS, the Grantor has agreed to enter into a Payoff Letter dated on or about the date of this Release pursuant to which the Administrative Agent agrees to release to the Grantor any and all right, title and interest the Administrative Agent and the Secured Parties may have in the Trademark Collateral identified in this Release, pursuant to the Agreement and Trademark Security Agreement;

WHEREAS, the Payoff Letter defines an "Effective Time".

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby agrees as follows:

1. Release of Security Interest. Administrative Agent, on behalf of itself and the Secured Parties, and its and their successors, legal representatives and assigns, hereby absolutely, unconditionally and irrevocably terminates the Trademark Security Agreement and terminates,

releases, extinguishes and forever discharges any and all security interests that it has pursuant to the Agreement and Trademark Security Agreement in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the "**Trademark Collateral**"):

(a) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule I hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (the "**Trademarks**");

(b) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Representations. The Administrative Agent hereby represents and warrants that it has full authority to execute and deliver this Release. This Release shall be binding upon the Administrative Agent's legal representatives, assigns and successors, and upon the Secured Parties and their legal representatives, assigns and successors. The Administrative Agent also hereby authorizes and requests the Director of the United States Patent and Trademark Office or his delegate to record this Release against the Trademark Collateral.

3. Further Assurances. Administrative Agent agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release, and the Administrative Agent agrees to execute such other releases substantially similar to this Release as necessary to release a security interest with respect to any foreign counterparts of any Trademark Collateral.

4. Counterparts. This Release may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Release delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Release.
