Exhibit A - ASSIGNMENT

This Assignment is by and between R. L. K. and Company, an Oregon corporation having a place of business at 27500 E. Timberline Road, Government Camp, Oregon 97028 ("RLK"), and Hood Rivers Distillers, Inc., an Oregon corporation having its principal place of business at 660 Riverside Drive, Hood River, Oregon 97031 ("Hood River"). Collectively, RLK and Hood River are referred to as "Parties." This Agreement is effective as of the date of signing by the last of the Parties to sign below (Effective Date).

The Parties understand and agree as follows:

1. Hood River has filed, and is the owner of record of, US Trademark registration application number 87/693,870 (The '870 Application) for the TIMBERLINE mark for goods described as "distilled spirits". Hood River has filed an amendment to allege use of the mark of The '870 Application.
2. RLK is desirous of obtaining all of Hood Rivers rights in The '870 Application, in the TIMBERLINE mark for distilled spirits, the goodwill of the Hood River's business symbolized by the TIMBERLINE mark and the right to sue for any past infringement of Hood River's rights in the TIMBERLINE mark.
3. For good and valuable consideration, receipt of which is hereby acknowledged, Hood River does hereby sell, assign, transfer and set over unto RLK all of Hood River's right, title, and interest in and to the TIMBERLINE mark, The '870 Application, the goodwill of the business of Hood River symbolized by the TIMBERLINE mark and the right to sue and recover for past infringement of the TIMBERLINE mark.
