## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “Agreement”), dated September 27, 2019 (the “Effective Date”), is made and entered into by and between GRIND LLC, an Oregon limited liability company (“Assignor”) and Damien Hawke (“Assignee”).
