**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This Release of Security Interest in Trademark Rights, dated as of September 30, 2019 (the "Trademark Security Release"), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as the Collateral Agent (in such capacity, the "Agent"), in favor of DITECH FINANCIAL LLC, a Delaware limited liability company ("Ditech"), GREEN TREE CREDIT SOLUTIONS LLC, a Delaware limited liability ("Green Tree Credit"), DITECH HOLDING CORPORATION, a Maryland corporation ("Ditech Holding"), REVERSE MORTGAGE SOLUTIONS, INC., a Delaware corporation ("RMS" and together with Ditech, Green Tree Credit and Ditech Holding, individually, each a "Grantor" and collectively, the "Grantors"). Capitalized terms used and not defined herein have the meanings given to such terms in the Existing Credit Agreement and the Security Agreement (each, as defined below).

WHEREAS, Ditech Holding entered into that certain Second Amended and Restated Credit Agreement, dated as of February 9, 2018 (the "Existing Credit Agreement"), pursuant to which the Lenders severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Existing Credit Agreement, the Grantors executed and delivered an Amended and Restated First Lien Security Agreement, dated as of February 9, 2018, in favor of the Agent (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest in all of such Grantor's right, title and interest in, to and under certain intellectual property, including the Mark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, in connection with the Security Agreement, the Grantors executed and delivered that certain Omnibus First Lien Trademark Security Agreement dated as of February 9, 2018 made by the Grantors, in favor of the Agent (the "Trademark Security Agreement") for recording with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 1, 2018 on Reel/Frame 6282/0097;

WHEREAS, the Obligations (as defined in the Existing Credit Agreement) secured by the Mark Collateral (as defined in the Trademark Security Agreement) have been repaid or otherwise satisfied; and

WHEREAS, the Agent therefore desires to release, terminate and discharge its Lien and continuing security interest in all of Grantors' right, title and interest in, to and under the Mark Collateral and grant all of its right, title and interest in, to and under the Mark Collateral to the Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent and the Grantors hereby agree as follows:

1. The Agent hereby releases, terminates and discharges to the Grantors (a) the Agent's continuing security interest in, right of setoff against and Lien on, and (b) any of the Agent's other rights, title or interest of any kind or nature in, to or under, the Mark Collateral, including, without limitation, the Marks listed on Schedule 1 hereto.

2. The Agent hereby authorizes and acknowledges the termination of the Trademark Security Agreement. At Grantors' expense, the Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby and terminate the Trademark Security Agreement.

3. This Trademark Security Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

4. This Trademark Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Trademark Security Release by facsimile will be as effective as delivery of a manually executed counterpart of this Trademark Security Release.
