## TRADEMARK AND PATENT SECURITY AGREEMENT

THIS TRADEMARK AND PATENT SECURITY AGREEMENT (this “**Agreement**”) is made as of October 1, 2019, by INNOVATUS FLAGSHIP FUND I, LP, a Delaware limited partnership (“**Agent**”), in its capacity as agent for the Lenders (as defined below); KRANOS CORPORATION, a Delaware corporation (“**Kranos Corporation**”), KRANOS RE CORPORATION, a Delaware corporation (“**Kranos RE**”), KRANOS IP CORPORATION, a Delaware corporation (“**Kranos IP**”), KRANOS IP II CORPORATION, a Delaware corporation (“**Kranos IP II**”), KRANOS IP III CORPORATION, a Delaware corporation (“**Kranos IP III**”), KRANOS DIAMOND SPORTS, INC., a Delaware corporation (“**Kranos Diamond**”), and FIELD TO FIELD, INC., a Delaware corporation (“**Field to Field**”; and together with Kranos Corporation, Kranos RE, Kranos IP, Kranos IP II, Kranos IP III, and Kranos Diamond, collectively, the “**Debtors**” and each individually, a “**Debtor**”).

### RECITALS:

A. Pursuant to that Credit and Security Agreement dated as of the date hereof by and among Debtors, guarantors party thereto from time to time, lenders party thereto from time to time (“**Lenders**”), and Agent (“**Credit Agreement**”), Lenders have agreed to extend credit, on certain terms and conditions (capitalized terms not otherwise defined herein have the meanings given under the Credit Agreement).

B. Loan Parties (including Debtors) have granted to Agent, for the ratable benefit of Agent and the Lenders, a security interest in all of their personal property and fixtures, including their Intellectual Property, pursuant to (i) the Credit Agreement and (ii) that certain Intellectual Property Security Agreement dated as of the date hereof by and among Debtors, Agent, and certain other parties thereto (the “**IP Security Agreement**”).

C. Debtors wish to execute this Agreement to supplement the terms of the Credit Agreement and the IP Security Agreement and to place of record Debtors’ grant of a security interest to Agent in Debtors’ trademarks and patents registered in the United States.

### AGREEMENT:

NOW THEREFORE, as an inducement to cause Lenders to extend credit to Borrowers, and for other valuable consideration, the receipt and sufficiency of which are acknowledged, it is agreed as follows:

**1. UCC Security Interest in Registered Trademarks and Patents.** Debtors hereby grant to Agent, for the ratable benefit of Agent and the Lenders, a security interest in the trademark and patent registrations of record with the United States Patent and Trademark Office (the “**USPTO**”) owned by Debtors and described in Schedule A (Trademarks) and Schedule B (Patents) hereto and all goodwill and other property associated therewith.

**2. Recordation.** Each of the Debtors authorizes Agent to record this Agreement with the USPTO.

**3. Other Agreements.** This Agreement is executed to supplement and further evidence the security interest granted to Agent under the Credit Agreement and the IP Security Agreement. The rights and remedies of Agent with respect to the security interest granted hereby are in addition to those set forth in the Credit Agreement, the IP Security Agreement, and the other Loan Documents, and those which are now or hereafter available to Agent or Lenders as a matter of law or equity. Each right, power and remedy of Agent or Lenders provided for herein or in the Credit Agreement, the IP Security Agreement, or any of the other Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy arising under this Agreement.




