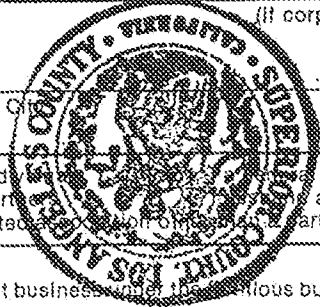

AMENDMENT NO. 10

TO

JOINT VENTURE AGREEMENT

This AGREEMENT, which amends the Joint Venture Agreement dated as of September 1, 1974 as currently in effect (the "Joint Venture Agreement") is made and entered into this 26th day of January, 1988 by and among LEP HOLDINGS, INC., a California corporation, and PEP COMMUNICATIONS, a California corporation, as follows:

1. Section 10(a) of the Joint Venture Agreement is amended to read as follows:

- (a) The Joint Venture shall be named ELP Communications and all business done or undertaken by it shall be done and conducted under any one or more of the five following names:
