### RELEASE OF TRADEMARK SECURITY AGREEMENT

October 11, 2019

WHEREAS, CALDERON TEXTILES LLC, an Indiana limited liability company, as successor in interest to Calderon Textiles, Inc. - (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

The Lender acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
