RELEASE OF TRADEMARK SECURITY AGREEMENT

October 11, 2019

**WHEREAS**, CALDERON TEXTILES LLC, an Indiana limited liability company (the “Grantor”) entered into that certain Trademark and License Security Agreement, dated as of March 28, 2012, in favor of BMO HARRIS BANK N.A., as agent (the “Agent”), which was recorded with the United States Patent and Trademark Office on April 2, 2012 at Reel 4773, Frame 0852 (the “Agreement”). Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Agreement.

**WHEREAS**, pursuant to the Agreement, the Grantor granted to the Agent for the benefit of the Secured Parties a security interest in the Trademark Collateral (as defined below), including, without limitation, the trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, without representation, warranty or recourse, hereby terminates and releases its security interest in and Lien on all of the Grantor’s right, title and interest in and to the following Collateral of Grantor (collectively the “Trademark Collateral”):


- (a) all of its Trademarks and all exclusive Trademark Licenses providing for the grant by or to Grantor of any rights under any Trademark, including the Trademarks identified on Schedule A attached hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

The Agent acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.
