**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of October 24, 2019 (the “Effective Date”), is made by Wilmington Trust (London) Limited, in its capacity as Collateral Agent (the “Agent”), in favor of the grantor party identified on the signature page hereto (the “Grantor”).

WHEREAS, pursuant to that certain Security Agreement, dated as of October 31, 2016, by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of October 31, 2016 (the “Intellectual Property Security Agreement”), for recordal with the United States Patent and Trademark Office and the United States Copyright Office;

WHEREAS, the Intellectual Property Security Agreement was recorded with (i) the United States Patent and Trademark Office on November 3, 2016 at Reel/Frame 040552/0227, (ii) the United States Patent and Trademark Office on November 3, 2016 at Reel/Frame 5913/0001 and (iii) the United States Copyright Office on November 4, 2016 at Volume/Document 9957/029;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Intellectual Property Security Agreement, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Patent Collateral, the Trademark Collateral and the Copyright Collateral, including (i) the patents and patent applications set forth Schedule A attached hereto, (ii) the trademark registrations and applications set forth in Schedule B attached hereto and (iii) the copyright registrations and applications set forth in Schedule C attached hereto, arising under the Security Agreement and the Intellectual Property Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Patent Collateral, the Trademark Collateral and the Copyright Collateral under the Intellectual Property Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Intellectual Property Security Agreement.
4. Further Assurances. The Agent agrees:
  - a) that they will, without delay, but in any event no later than five Business Days from the date of this Release that it will file and take all steps required to evidence the release on all relevant public registers, including but not limited to the Patent and Trademark




Office and the United States Copyright Office (and provide such evidence to the Grantors in copy); and

- b) to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
