INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of October 25, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, this “**IP Security Agreement**”), is made by PRECISION SHOOTING EQUIPMENT, INC., a Delaware corporation (“**Borrower**”), PRECISION FINISHING, INC., an Arizona corporation (“**Precision Finishing**”), PSE INTERNATIONAL, INC., a Delaware corporation (“**PSE International**”), PAUL E. SHEPLEY FAMILY LIMITED LIABILITY PARTNERSHIP, an Arizona limited partnership (“**Trust**” and, together with Borrower, Precision Finishing and PSE International, each a “**Grantor**” and, collectively, the “**Grantors**”), in favor of SUNFLOWER BANK, N.A., a national banking association (together with its participants, successors and assigns, “**Lender**”).

WHEREAS, pursuant to the Loan and Security Agreement, dated as of the date hereof, by and among the Grantors and Lender (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Loan Agreement**”), the Lender has agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein. Capitalized terms used and not otherwise defined herein have the meanings given such terms in the Loan Agreement, as amended.

WHEREAS, under the terms of the Loan Agreement, each Grantor has granted to the Lender, a security interest in all of each Grantor’s right, title, and interest in and to certain Collateral, including all of each Grantor’s copyrights, trademarks, and patents, as applicable, and has agreed as a condition thereof to execute this IP Security Agreement with respect to certain of its copyrights, trademarks, and patents in order to record the security interests granted therein with the United States Copyright Office or United States Patent and Trademark Office, as applicable (or any successor office or other applicable government registry).

NOW, THEREFORE, in consideration of the above premises, each Grantor hereby agrees with the Lender, as follows:

1. Grant of Security. Each Grantor hereby grants to the Lender, a security interest in all of each Grantor’s right, title and interest in and to the following, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations:

(a) all intellectual property identified in Schedule 1 and the goodwill of the business connected with the use of, and symbolized by, each such intellectual property; and

(b) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations of any of the property described in (a) above, and all income, royalties, damages and other payments now and hereafter due and/or payable with respect to any of the property described in (a) above.

2. Recordation. Each Grantor authorizes Lender to request that the Register of Copyrights, the Commissioner for Patents or the Commissioner for Trademarks, as applicable, and any other applicable United States or foreign government officer record this IP Security Agreement.
3. Execution in Counterparts. This IP Security Agreement may be executed in any number of counterparts (including by telecopy or other electronic transmission), each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
4. Governing Law. Section 9.7 of the Loan Agreement is incorporated mutatis mutandis.
5. Conflict Provision. This IP Security Agreement has been entered into in conjunction with the provisions the Loan Agreement. The rights and remedies of each party hereto with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Loan Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this IP Security Agreement are in conflict with the Loan Agreement, the provisions of the Loan Agreement, as applicable, shall govern.
6. Notice. Section 19.6 of the Loan Agreement is incorporated mutatis mutandis.
