This NOTICE OF SUCCESSION OF AGENCY (this "Notice"), dated as of October 29, 2019 (the "Effective Date"), is executed by Deutsche Bank Trust Company Americas, in its capacity as Administrative Agent under the Original Agreements (as defined below) (the "Prior Agent"), and Deutsche Bank AG New York Branch, in its capacity as Administrative Agent under the Current Agreements (as defined below) (the "Successor Agent").

WHEREAS, pursuant to that certain Credit Agreement, dated as of April 16, 2013, by and among ABC Supply Holding Corp., a Delaware corporation ("Holdings"), American Builders & Contractors Supply Co., Inc., a Delaware corporation (the "Borrower"), Prior Agent and certain other parties thereto (the "Original Credit Agreement"), the Prior Agent and certain grantor parties identified on the signature pages thereto (the "Grantors") entered into that certain Security Agreement, dated as of April 16, 2013 (the "Original Security Agreement"), and the Trademark Security Agreement, dated as of November 17, 2015 (the "Trademark Security Agreement"), pursuant to which the Grantors granted a security interest in and to certain collateral;

Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Agent under the Trademark Security Agreement, which security interest is now succeeded by and transferred to the Successor Agent.
