**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

3. This Termination and Release shall be governed by the laws of the Commonwealth of Massachusetts.

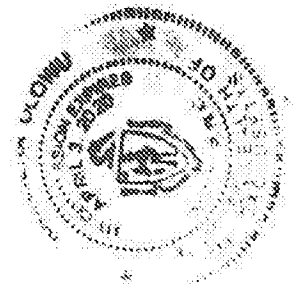
